Subject: Complaint in regard to blocking entrance to my home and performing an act of caste based insult and atrocity under SC /ST act.

Respected Sir,

- I, Sachin Siwa, son of Kanchhi Siwa, resident of Washabari TG Bagrakote Tea Garden Mal, Jalpaiguri, West Bengal 734501 would like to state that -
  - 1. That I am employed as a driver/guard by Mr. Bajranglal Agarwal, who is also the rightful owner of the godown cum guard house, where I reside situated at Opp. Bajaj Showroom, Behind Tanishq, 2<sup>nd</sup> Mile, Sevoke Road, Siliguri 734001.
  - 2. That on 06.06.2025 in utter disregard to law, Mr. Pravin Kumar Agarwal, Mahesh Kumar Agarwal, Dinesh Kumar Agarwal, all are Sons of Late Laxmi Narayan Agarwal, Himanshu Agarwal S/o Mahesh Kumar Agarwal, Subham Agarwal S/o Dinesh Kumar Agarwal and Tanish Agarwal S/o Pravin Kumar Agarwal who are residing near the premises and are neighbours blocked the access to my place by installing an iron gate.
  - 3. That the abovenamed persons on 06.06.2025 came to my place of residence and asked me to immediately leave my house and never to return back. When I denied, the said miscreants started abusing me held me by my collar and threw me out of the godown cum guard room. On 07.06.2025 when I tried to enter my house again the abovenamed persons again threatened to tie and beat me up. They also threatened me that if I or my employer or any of his family members try to enter the godown and/or guard house, they will have to face dire consequence.
- 4. That today, i.e on 09.06.2025 when in the morning I was walking toward the godown cum guard room they started hurling abuses against me by making

derogatory and casteist remark against me and issued life threats to me, warning me of serious consequences. These persons are well aware that I am a member of schedule caste and this remarks have hurt my sentiments and dignity. That the above named persons have not only blocked my entrance to my home, where all my essential kitchen utensils and belongings are kept but also caused huge emotional trauma and public disgrace to me. As a result, I am unable to cook food or carry out basic daily activities, which is severely affecting my health and daily life.

- 5. This is a not just a matter of illegal obstruction, but a deliberate act of harassment and intimidation that is targeting me and putting my life and livelihood in danger. I request you to kindly register an FIR against the said persons against relevant provision of law.
- 6. In the prevailing circumstance I request you to take immediate and appropriate action so that I can have uninterrupted access to my home by removing the gate that is obstructing the path and also protect me protection from any further threats and atrocity.
