I,PINKI ROY,D/o- Sri Shyamal Roy, Permanantly residing at College Para PO- Prasannangar, PS-Rajganj Dist- Jalpaiguri, would like to inform you that I have been working as DEO at the office of Borough 4 & 5.As such as usual on 10/12/2024 at about 11:10 am while I was going to my Office that time I met an accident at the Road No 3, Shaktighar, W/N-31 SMC, Dist-Jalpaiguri, Pin-734005, when suddenly, one vehicle bearing No-WB 76 9822 was pushed hard at the back side of my scooty bearing No-WB 72 X0265 as a result I was fallen down on road and sustained injury on different parts of my body including my legs, which effected badly due to such accident as a result I informed the matter to my relatives and office colleague who came to the spot and rushed me for the treatment at Heritage Hospital situated at 446/N Burdwan Road, Siliguri, where doctor after proper investigation and following the nature of my injury advised me for going through the surgery on knee of my left leg on immediate manner. Therefore without causing any unnecessary delay I have done my said knee surgery from the Global Orthopedic Centre at patna, in the State of Bihar.

During said period as I was being badly effected for my injuries, following prolonging treatment of surgery, I along my family members were completely shattered from within and get disoriented for my future and as such I could not lodge the complain on the actual time of incident.

Having no alternatives and seeing the sensitiveness of my injury towards my future prospective and also the fact that I have been still under treatment, I decided to take your recourse for initiating proper action through due procedure of law.
