I, Sri Manik Das, (45), A.E. & Station Manager of NJP Gate Bazar CCC, (S/O: Sri Akshay Das), do hereby lodge complaint against aforesaid Shri Adhir Chandra Saha to the effect that, on 10.06.2025 in course of inspection, myself along with Bijoy Lakra, S/O: Bernard Lakra, Divisional Engineer (Elect.), Shri Bhaben Roy, S/O: Late N.C Roy, SO, both of Darjeeling Regional office, WBSEDCL, Shuvankar Neogi, Sr. T.S.H of NJP Gate Bazar CCC & other technical staff of NJP Gate Bazar CCC had been to the premises of Adhir Chandra Saha at village South Colony Bazar PO: Sahudangihat at 14.40 Hrs. Prior entry to the premises, a notice was issued in the name of Adhir Chadra Saha for inspection of the said premises which was received by Manish Singh, representative of the Adhir Chandra Saha under his signature. I arrange to call witnesses from the vicinity but none turned up. However, in presence of the representative of the consumer we conducted inspection.

During inspection in presence of the representative of the consumer it was found that, there has one domestic connection vide consumer id: 402187334 in the name of Shri Adhir Chandra Saha in the premises, which was on 26.05.2025 due to nonpayment of electric bills of due amount Rs. 8,025.00, but the service was reconnected by the consumer to run the electrical appliances to his domestic premises. Due to this unauthorized use of electricity WBSEDCL has occur a loss of revenue. On detection of such illegal use of electricity service line was disconnected & meter was dismantled. During inspection load of electricity consumption as observed in the same premises was 2.126 KVA. On being asked, Manish Singh, representative of the Adhir Chandra Saha admitted his guilt for committing aforesaid offence.
