Thereafter Sri Bharat Bhusan, G.S.T officer on 13.05.2025 visited my husband's office which is owned by me and made a panchnama showing the forged documents to me and my husband.

I therefore request you to look into the matter to take necessary action against the miscreant or miscreants who has forged my documents and used my electricity bill of my office at Ward No.14, Pan Card and Adhar Card.

Please treat this as very urgent and act accordingly.
