Sir,

In producing herewith arrested accused person namely Bablu Sarkar (35 yrs) S/O Late Lakham Sarkar of Sarbohara Colony, ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles vize i) 12 (twelve ) sealed Plastik Bottles of Himalayan Tuk Tuk 80 up country spirit each containing 600 ml. each , Amounting of Rs 60/- x 12 =RS.720/-) marked as Exhibits-A , ii) 01 (one) sealed Bottle of Bottles of Himalayan Tuk Tuk 80 up country spirit each containing 600 ml., Amounting of Rs 60/- in which was taken out from mother packet box as sample for examination, marked as Exhibits-A1, as per seizure list.

I, ASI Rabin Lama of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Bablu Sarkar (35 yrs) S/O Late Lakham Sarkar of Sarbohara Colony, ward No. 28, PS- Siliguri, Dist- Darjeeling to the effect that on 12.06.25 at 19.35 hrs acting on secret source information that the above noted person was busy to sale Id liquor illegally in a open place situated at Sarbohara colony Sabji Bazar, ward no. 28 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no.557 dated 12.06.25 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Debasish Das, C/160 Soumen Sarkar both of Siliguri PS left for Sarbohara colony Sabji Bazar, ward no. 28 under Siliguri PS to verify the veracity of the information vide Siliguri PS G.D.E No.558 dated 12.06.25. On reaching at 19.55 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his identity as noted above. On being asked he stated that he used to sale the 80 up Country Spirit to locality without any valid documents. On being asked he could not produce any valid documents in respect of the said liquor. On searching i) 12 (twelve ) sealed Plastik Bottles of Himalayan Tuk Tuk 80 up country spirit each containing 600 ml. each , Amounting of Rs 60/- x 12 =RS.720/-) marked as Exhibits-A , ii) 01 (one) sealed Bottle of Bottles of Himalayan Tuk Tuk 80 up country spirit each containing 600 ml., Amounting of Rs 60/- in which was taken out from mother packet box as sample for examination, marked as Exhibits-A1, and

accordingly I seized the same as per seizure list as per seizure list as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. He also stated that he is doing this liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 20.12 hrs and 20.37 hrs. As such I arrested him U/S-35(1) BNSS after observing all sorts of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Bablu Sarkar (35 yrs) S/O Late Lakham Sarkar of Sarbohara Colony, ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.


