namely Suraj Sahani @ Puker & his above noted family  
members, came there and started abusing him in  
filthy language and when my other sons namely,  
(2) Munna Sahani & (3) Manoj Sahani, both sons

and they received severe injury on their persons  
and immediately shifted to Siliguri Distt Hospital

Medical College & Hospital for and admitted there

Sahani, released from Siliguri Distt. Hospital after  
primary treatment, the intention of them was to kill my son.

Sir, my one son namely Mohan Sahani's condition  
is very serious and he is fighting with life & death,  
at North Bengal Medical College & Hospital.  
So, please take necessary action against above noted  
alleged persons.
