In producing herewith one arrested accused person namely Md. Chand (M/28) S/O Lt. Md. Naser of Swaminagar Colony, Near Kali Mandir, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling along with the following seized articles as per proper seizure list:

1. Total 07 (Seven) bottles of Officer's Choice Grand Whiskey (each bottle containing 180ml), Total -1260 ml/1.260 L - marked as 'Exhibit -A'.
2. Total 06 (six) bottles of Himalayan Tuk Tuk 80 UP Country Spirit , each bottle containing 600 ml , total 3600 ml / 3.6 L - marked as 'Exhibit - B'

I, ASI Majaffar Rahaman Mondal of Khalpara TOP under Siliguri Police Station do here by lodged a written complaint against the above noted accused person named Md. Chand (M/28) S/O Lt. Md. Naser of Swaminagar Colony, Near Kali Mandir, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling to the effect that today on 12.06.2025 at 18.25 hrs. I received a credible source information that one person is selling huge quantity of liquor/ alcohol in an abandoned house at Chanapatty area under Siliguri Police Station in higher price than the actual value for his wrongful gain without any documents/license. Subsequently, after sharing the information with my superiors and as per their direction, myself along with force of Khalpara TOP left for the place to work out the information. The fact was diarized in Khalpara TOP-II under Siliguri Police Station GDE No- 357 Dated- 12.06.2025.

After we reached at the spot at 18.55 hrs. and on being identified by the source our police party held raid in an abandoned house at Chanapatty and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the liquor/ alcohol in open market at Chanapatty area since long for his wrongful gain without any valid documents/license. Accordingly, I seized the above noted articles from his possession after preparing proper seizure list and arrested him after maintain all formalities in presence of witnesses. The seizure was made on 12.06.2025 in between 19.10 hrs to 19.30 hrs. under videography.

Under the above circumstances, I request you to start a specific case may kindly be started against the accused person namely Md. Chand (M/28) S/O Lt. Md. Naser of Swaminagar Colony, Near Kali Mandir, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling under proper section of law and arrange for investigation.
