I Smt. Budhina Paswan (Mobile No.9144198410) wife of Sri Uttam Paswan, resident of Mahabirsthan, Sarbahara Colony, Ward No.28 of S.M.C., P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, Pin-734004 beg to report you the following facts:-

1. That yesterday on 10.06.2025 at about 9.00 P.M. to 10.00 P.M. there is a place near of my house where some persons namely (i) Ganesh Paswan (ii) Rambabu Pasawan both are son of Sri Laxman Paswan, (iii) Smt. Lila Paswan wife of Sri Laxman Paswan, (iv) Smt. Nirmala Paswan wife of Gopal Paswan, (v) Smt. Aarti Paswan wife of Akash Paswan, daughter of Gopal Paswan, (vi) Sri Akash Paswan son of Unknown, (vii) Raja Paswan, (viii) Nandan Paswan (ix) Mohan Paswan all are son of Phulena Paswan, (x) Bishal Paswan son of Sri Jai Jai Ram Paswan, (xi) Ganesh Paswan, (xii) Kartik Paswan both are son of Sri Bala Paswan, (xiii) Smt. Lalita Paswan wife of Sri Bala Paswan and (xiv) Smt. Jyoti Paswan wife of Mohan Paswan and 4 to 5 persons their associates all are resident of Mahabirsthan, Sarbahara Colony, Ward No.28 of S.M.C., P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, Pin-734004, were started to create nuisance and insulted me and my family members by using unparliamentarily words abusing very filthy languages when I along with my daughter namely Smt. Moni Paswan wife of Kamal Paswan, daughter of Sri Uttam Paswan went to stop them from disturbing, make noise and abusing me and my family members, One Ganesh Paswan son of Sri Laxman Paswan and their associates (Goons) suddenly Physically assaulted me and my daughter brutally attacked with fists and blows and by lathi and leather belt got severe injury of our persons in front

of my house at Mahabirsthan, Sarbahara Colony, Ward No.28 of S.M.C., P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling.

After that on that time my younger son namely Sawan Paswan son of Sri Uttam Paswan came to the incident and try to rescue me and my daughter's from all above named persons, all are Physically assaulted with fists and blows and by lathi and leather belt got severe injury on his head and chest and then they also physically assaulted my daughter with their wrong intensions and touched my daughter's private body parts use of criminal force with intent to disrobe and outrage her modesty after that anyhow I tried to save my daughter, son and myself from their hands and my daughter and my younger son and me went to the Siliguri District Hospital, Siliguri, Dist. Darjeeling for medical treatment.

During such operation, they snatched Rs.2,000/- from my aforesaid younger son's pocket.

2. That on 28.05.2025 at about 9:00 P.M. to 9.30 P.M. my aforesaid younger son was coming from Mahabirsthan Market to his home suddenly (i) Ganesh Paswan (ii) Rambabu Paswan both are son of Sri Laxman Paswan, (iii) Smt. Lila Paswan wife of Sri Laxman Paswan, (iv) Smt. Nirmala Paswan wife of Gopal Paswan, (v) Smt. Aarti Paswan wife of Akash Paswan, daughter of Gopal Paswan, (vi) Sri Gopal Paswan son of Late Lalu Paswan, (vii) Raja Paswan, (viii) Nandan Paswan, (ix) Mohan Paswan all are son of Phulena Paswan, (x) Bishal Paswan son of Sri Jai Jai Ram Paswan, (xi) Ganesh Paswan, (xii) Kartik Paswan both are son of Sri Bala Paswan, all are residing at above mentioned address they all were abusing my son very filthy languages and hearing such, my younger son request them and they became violent and physically assaulted my aforesaid son namely Sawan Paswan by fists and blows and by kicks. They tried to murder my son by hitting by a sharp cutting chopper on his head, but anyhow he saved his life from such hit and action.

During such operation, that time also they snatched Rs.1,000/- from my son's pocket.

Now, they are abusing me and my family members very filthy languages and threatening me and my aforesaid son by saying that if

I go to the Police station to registered/lodged any complain against them then they will murder my aforesaid son and drag his body outside from the city.

3. That I, my daughter and my son were got serious injury on our heads, Chest, lower abdomen and whole body swelling, now we are got very serious injury on our persons.
4. That due to such assault upon me and my aforesaid daughter and my son and due to their such attempt to murder of my said son namely Sawan Paswan in such cruel manners, they sustained severe injuries on their persons and they were medically treated at Siliguri District Hospital, Siliguri, Dist. Darjeeling on 10.06.2025 at about 10.00 P.M. and still they are under medical treatment.
5. That due to serious injury caused due to such assaulted by them upon my aforesaid daughter and son and me delay is caused for lodging this F.I.R. which may kindly be condoned.
6. That the Xerox copies of medical treatments papers are enclosed here with.

I therefore request you to kindly take necessary steps against the aforesaid culprits for the commission of the aforesaid offences upon my aforesaid daughter and son and me.
