I, Sarmila Begum, daughter of Nizam Ali, s/o Vivekananda Road, Khalpara, Ward no-7, Siliguri, wants to inform you about the brutal attack done by Sahil Khan s/o Late Shakil Khan s/o Khalpara Chanimandir Road, Ward no-7, Siliguri, to my sister named Jasmina Khatoon d/o Nizam Ali.

That the said Sahil Khan with the aim to extort money came to Jasmina Khatoon's house today the 13th of June 2025 at around 00:15 A.M. and when Jasmina denied, Sahil Khan attacked with the intention to kill her with knife at various sensitive parts of her body. That when the lady name Mena Begum went to protect Jasmina, he also attacked her but she however escaped. That soon Jasmina Khatoon was taken to District Hospital where she is presently admitted and is fighting for her life and is on the verge of life and death.

Moreover I would also like to inform the Sahil Khan had a habit of extorting money from the locals by giving using knife and arms and several complaints are already lodged against him.

Sir I humbly request you to take action against Sahil Khan as per law.
