Dear Sir, I pinki Malakar, do - late Samir Malakar, resident of Eskon Mansir Road, Krishna Apartment, P.O. Sanoke Road, P.S. Bhaktinagar police station, Dist - Darjeeling would like to draw your kind attention on the following facts:-

1. That I run a ladies beauty parlour namely 'Glamour and Shine' at Eskon Mansir Road from last 6 years.
2. That recently I hired a lady employee namely Prassana Mangar in the month of April 27, 2025 and from she worked with me in my parlour. But recently I went to Kolkata on 1st of June, 2025 for the examination of my daughter. At that particular of time the key of my parlour was given to my employee Prassana Mangar.
3. That I came back to Siliguri on 6th

of June 2025. Then I went to my parlour for continuing my business on 8th of June at that time my parlour was closed and the key was in the custody of my employee. For that I asked her to open the parlour or to give the key to me but very unfortunately she refused to give back the key to me, anyhow I managed to open my parlour and started my business.

4. That suddenly my employee Pansarna Mangar came before my parlour and asking me to give salary without working. I gave 3000/- her on the spot but in spite of that without any justified reason she started arguing with me and threatened me with dire consequences, when I protested the same she went from my parlour and back with two unknown persons and they used strong languages towards me and without any reason started torturing me with fist and blows and tried every means to kill me and outrage my modesty, for that reason I sustained grievous injuries over my body. After that I went to Siliguri District Hospital for immediate treatment and I received treatment in the concerned hospital.

Therefore, I request you to take appropriate legal action as per the provisions of law, so that
