- [2] Five (05) bottles of Himalayan Gold country spirit (each bottle containing 600 ml.)

I, ASI Dipak Karmakar S/o Lt. Dulal Karmakar of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against the above-noted arrested accused person namely Barun Kumar Sarkar to the effect that today on 12/06/2025 at 14.15 hrs, I received source information that one person has stored the illicit liquor and is selling the same in his hotel style as "Baba Hotel" at Chandal more under Bhaktinagar PS, Dist.- Jalpaiguri without any valid license. Accordingly, the fact is diarized in the General Diary vide Bhakti Nagar PS GDE No.647 Dated 12/06/2025 and shared the information to IC Bhakti Nagar PS. As per his kind direction, I along with force left for Baba Hotel, Chandal more under Bhaktinagar PS, Dist. Jalpaiguri to verify the veracity of source information in hand. We reached there as identified by the source we held a raid at the said hotel of Barun Kumar Sarkar and managed to apprehend him. On being asked he disclosed his identity as noted above and stated that he has stored the illicit liquor and is selling the same without any valid license for his wrongful gain. On further search, the above-noted seized articles were recovered from his hotel. On-demand he failed to produce any valid license/papers for selling and storing such articles. On further interrogation, he stated that he had been involved in selling and storing illicit liquor without any valid license for the last few months for his illegal gain. Then, I seized the abovementioned liquor under the proper seizure list and arrested the person mentioned above after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 16.35 hrs. to 17.10 hrs under proper videography.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused person namely Barun Kumar Sarkar (62 yrs) S/o Lt. Dilip Kumar Sarkar of A/P C/O Bhajoram Das of Jyoti Nagar, PS- Bhakti Nagar, Dist- Jalpaiguri, P/A Kadamtola, PS- Dhupguri, Dist-Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
