Sir,

In producing herewith four (04) arrested accused persons namely (i) Swapnanil Saha @ Bublai (21) s/o Subrata Saha of Niranjannagar Colony, near Goghomali High School, ward no. 37, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] (ii) Raj Chakraborty (18) s/o Rabin Chakraborty, of Ashighar Colony, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] (iii) Partha Singha (19) s/o Krishna Singha, of Falbazaar, Das Ghar Bridge, ward no. PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] and (iv) Shibu Roy @ Shakti (27) s/o Ramesh Roy, Uttar Ektiashal Khudiram Colony, Near Himalayan School, PO- Sevoke Road, PS- Bhaktinagar, dist- Jalpaiguri arrested u/s- 35 BNSS along with following seized articles viz:

- (1) One iron made Screw driver measuring 11.5 inch (approx.) including iron butt found from the possession of Swapnanil Saha which was kept in his right hand.
- (2) One iron made wrench measuring 9.5 inch (approx.) found from the possession of Raj Chakraborty which was kept concealed on his back side.
- (3) One iron made hammer measuring 12 inch (approx.) found from the possession of Partha Singha which was kept in his left hand.
- (4) One iron made hammer measuring 12 inch (approx.) found from the possession of Shibu Roy @ Shakti which was kept in his right hand.

I, SI Agen Lepcha, S/O- Lt. Dup Tshering Lepcha of Ashighar OP under Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the above-noted accused persons namely (i) Swapnanil Saha @ Bublai (ii) Raj Chakraborty (iii) Partha Singha (iv) Shibu Roy Saha @ Shakti and others to the effect that today on 12/06/2025 at 22:35 hrs while performing night patrolling duty received source information that 12/14 youths have assembled near Tharughati Jungle under Bhaktinagar PS with a view to commit dacoity in a house at Tellipara area. Accordingly, the fact was diarized in GD vide Ashighar OP GDE No- 412 dated 12/06/2025. Subsequently, after sharing the information with my superior and as per his direction, I along with ASI- Dinesh Ch. Roy, ASI Ram Prasad Adhikary, C/970 Bikash Roy, C/1547 Prabir Das, HG/ 1114 Rabi Das all of Ashighar Out Post left for the Tharughati Jungle to verify the veracity of source information. At about 22:50 hrs after reaching near Tharughati Jungle under PS- Bhaktinagar, I met my source and being pointed by the source we started walking towards Tharughati Jungle. At around 23:10 hours, we reached at Tharughati Jungle and began to cordon off the suspected individuals identified by my source. We had a strong reason to believe that they were preparing to commit a cognizable offence and were about to leave the area. However, upon noticing the police approaching, they attempted to flee. After a hot chase, we successfully apprehended four accused individuals along with the seized articles mentioned above. Unfortunately, a number of others managed to escape from the spot taking advantage of darkness.

During interrogation, the apprehended individuals admitted that they had gathered there with the intent to commit dacoity at a house in the Tellipara area under the Bhaktinagar police station.

I thereafter, seized the above-noted weapons under the proper seizure list and videography duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 23:19 hrs to 23:26 hrs. Following that, I arrested the above-noted accused persons u/s 35 BNSS under a proper memo of arrests duly signed by the accused persons and also supplied a copy of the memo of arrest to them.

Subsequently, I brought the arrested accused persons along with seized articles to Bhaktinagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house in Tellipara area.

Hence, under the above noted facts and circumstances a specific case may kindly be started under proper section of Law against the above noted arrested accused persons viz. (i) Swapnanil Saha @ Bublai (21) s/o Subrata Saha of Niranjannagar Colony, near Goghomali High School, ward no. 37, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] (ii) Raj Chakraborty (18) s/o Rabin Chakraborty, Ashighar Colony, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] and (iii) Partha Singha (19) s/o Krishna Singha, of Falbazaar, Das Ghar Bridge, ward no. PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] and (iv) Shibu Roy @ Shakti (27) s/o Ramesh Roy, Uttar Ektiashal Khudiram Colony, Near Himalayan School, PO- Sevoke Road, PS- Bhaktinagar, dist- Jalpaiguri [not verified] and others and arrange for its investigation.
