In producing herewith the 03 (three) arrested accused persons including 01 (one) lady accused namely 1] Ikbal Hossain (M/35 yrs approx), S/O- Lt Md. Abdul Malek of Kashim Bazar, PO- Matigara, PS- Mothabari, Dist- Malda (not verified), 2] Md. Hasanul (M/34 yrs approx), S/O- Md. Basanta Pally near Gas godown, PO- Pradhannagar, PS- Matigara, Dist- Darjeeling (not verified), 3] Fatema Begum (F/30 yrs approx), W/O- Md. Hasanul of Sukanta Pally near Gas godown, PO- Pradhannagar, PS- Matigara, Dist- Darjeeling (not verified) along with the following seized article under proper seizure list :-

- (i) One transparent plastic packet containing suspected to be brown sugar weighing 305 (three hundred and five) grams and marked as 'Exhibit- A'. from the joint possession of Md. Hasanul and Fatema Begum.
- (ii) One black colour plastic carry bag containing Exhibit-A and marked as 'Exhibit- B'. from the joint possession of Md. Hasanul and Fatema Begum.
- (iii) One black colour bag having two compartments styled as RADHIKA HYDRAULICS containing Exhibit-B and marked as 'Exhibit- C'. from the joint possession of Md. Hasanul and Fatema Begum.
- (iv) One transparent plastic packet containing suspected to be brown sugar weighing 568 (five hundred and sixty eight) grams and marked as 'Exhibit- D'. from the possession of Ikbal Hossain.
- (v) One black colour plastic carry bag containing Exhibit-D and marked as 'Exhibit- E'. from the possession of Ikbal Hossain.
- (vi) One black colour bag pack having three compartments styled as Duckback containing Exhibit-E and marked as 'Exhibit- F'. from the possession of Ikbal Hossain.
- (vii) One Royal Enfield Meteor 350 motor cycle brown and black colour having display no- WB 74 BJ 5198 and marked as 'Exhibit- G'. from the joint possession of Md. Hasanul and Fatema Begum.

I, PSI Avijit Banik, of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint to the effect that on 12.06.2025 at about 12:30 hrs, received a specific information provided by a credible source that 03 (three) persons including 01(one) lady will come to Matigara Bazar under Matigara PS to deal in huge quantity of illegal suspected to be Brown Sugar.

Hence, there was a strong reason to believe that there is every chance of committing a cognizable offence under NDPS Act and to check the veracity of information, I reduced the information in writing vide Matigara PS GDE No. 629, Dated 12.06.2025 and I intimated the information to Shri Arindam Bhattacharjee, I/C Matigara PS, SPC who brought the information to the superior and after obtaining necessary order at about 12:45 hrs myself, along with a team of Matigara PS, SPC consisting of ASI Pema Dorjee Sherpa, ASI Bikash Roy, C/219 Sanatan Chitrakar, C/523 Sanjit Kundu, LC/1286 Anisha Chhetri all are of Matigara PS, SPC took departure vide C.C. No- 1834/25 dated 12.06.2025 from Matigara PS, SPC for Matigara Bazar under Matigara PS with investigation kit containing envelope, white paper, sealing wax, gum, seal, digital weighing machine and other investigation kits by a Govt. vehicle to work out the information and the same was diarized vide Matigara PS GDE No. 631, dated- 12.06.2025.

At the same time I also informed the videographer namely Somnath Chatarjee, S/O- Sushil Chatarjee of Aurobindo Pally, Gokhel Road, W/No. 22, PS- Siliguri, Dist- Darjeeling to be present at Matigara Bazar, under Matigara PS, SPC to prepare the video of whole process of search and seizure if any. On 12.06.2025 at about 12:55 hrs, we reached at Matigara Bazar area under Matigara PS.

And I met with my source and he briefed me about the detail information and told me that the dealing will be done near Chota Hanuman Mandir. Before that I looked up for public witnesses to the entire process of search and seizure. I found so many people but two of them gave their willingness to act as independent witnesses. The particulars of the witnesses are as follows 1] Sanjay Gupta (35 yrs), S/O- Lt. Prem Chand Gupta of Matigara Bazar, PO+ PS- Matigara, Dist- Darjeeling and 2] Bikram Sahani (27 yrs), S/O- Sibji Sahani of Matigara Bazar, PO+ PS- Matigara, Dist- Darjeeling and I briefed them about the information we had and requested them to stand as witness, who agreed to be stand as witness during the process of search and seizure and other process thereafter.

In the meanwhile, I/C, Matigara PS sent a message to SDO, Siliguri to depute an Executive Magistrate during search & seizure of NDPS substances as per norms vide ORG No. 1830/25, Dated- 12.06.2025. But after a telephonic conversation, it came to know that due to engage in other duty and short notice, there are no Executive Magistrate available to perform the duty.

In the above circumstances and the gravity of the information, if any delay occurred, the accused persons may escape. Hence, as per order of superior, I/C, Matigara PS directed Shri Sajal Roy, Inspector of Police, Officer in Charge of NBMC OP under Matigara PS, SPC to be present at the place of occurrence to supervise the search & seizure if any. Accordingly Shri Sajal Roy left for the place of

At about 13:05 hrs, my source identified the suspected persons and we found that two persons including the lady is seating at a Royal Enfield motor cycle and the other person is standing near them with a bag pack. After a hot chase we managed to apprehend all of them. I introduced myself and the raid team members as Police officers. I appraised them about the information in hand that they had in their possession a huge quantity of brown sugar on their belongings and started to examine them thoroughly. On interrogation they disclosed their name and address as mentioned above. At first they denied regarding the information but I told them that I want to search them and their belongings. Eventually they admitted that they came at Matigara Bazar for dealing brown sugar and on interrogation the person with the bag pack stated that he came from Malda in the R15 motor cycle to deliver brown sugar to his designed customers. And some quantity of brown sugar already has been delivers to the persons who are sitting at the Royal Enfield motor cycle. And the remaining parts of brown sugar is kept at his bag pack. Other two persons stated that they came in the Royal Enfield motor cycle and received the brown sugar from the person who came from Malda which is kept at the bag which is kept in front of the meter of their Royal Enfield motor cycle.

As per provisions of section 50 of the NDPS Act, 1985 (as amended) I explained to the above noted detained persons that they have the legal right to tender their personal search in front of an Executive Magistrate or a Gazetted Officer and the same was given to them in writing. In reply they wanted to be searched before any officer and they do not want to search the police team. At about 13:25 hrs Shri Sajal Roy, O/C NBMC OP under Matigara PS in the rank of Inspector of Police arrived at the spot as a Gazetted Officer where I briefed him the information in a nutshell. Also introduced the witnesses as noted above.

On further interrogation, the detained persons admitted in front of the Gazetted officer that they are in conscious possession of a huge quantity of Brown Sugar.

Thereafter, as instructed by the Gazetted officer under his supervision and in presence of the two independent witnesses I searched the two male persons. On searching Ikbal Hossain found one Reddish colour Oppo F 25 pro 5G mobile phone having IMEI No- 860600070850652/645 and bearing Jio sim having no- 9609089045 and on searching the bag pack which is carrying by Ikbal Hossain found one transparent plastic packet containing suspected to be brown sugar which is wrapped in a black colour plastic carry bag. On weighting the packet was found as 568 gram. And on searching Md. Hasanul found one Golden colour Vivo V-40 e mobile phone having IMEI No- 866729078235758/41 and bearing Airtel sim having no- 9800200724 from his possession.

The lady constable searched the lady person namely Fatema Begum and found One dark green colour keypad ITEL mobile phone having IMEI No- 358161167793080/98 and bearing Airtel sim having no- 8116599108 from her possession. During the search of the Royal Enfield motor cycle which was found in joint possession of Md. Hasanul and Fatema Begum I found one black colour bag and on searching the black colour bag I found one transparent plastic packet containing suspected to be brown sugar wrapped in a black colour plastic carry bag. On weighting the packet it was found as 305 gram.

On interrogation, Ikbal Hossain stated that he came from Malda in the R15 motor cycle bearing display no- WB 66 AP 5511 and brought the suspected to be brown sugar from Malda to deliver his designated customer at Biswas Colony. Some quantity of brown sugar has already delivered to Md. Hasanul and Fatema Begum and the remaining portion will be delivered to some other customers at Biswas Colony area under Matigara PS. On interrogation Md. Hasanul and Fatema Begum stated that they came from their house at Sukanta Pally near Gas godown under Matigara PS in the Royal Enfield motor cycle bearing display no- WB 74 BJ 5198 to receive the brown sugar. They already received the brown sugar and will sell the brown sugar to their designed customers. Then, I asked them to produce the valid license/ documents for carrying and possessing the huge quantity of illegal narcotics contraband articles but they failed to produce any legal papers.

After weighting the transparent plastic packet which was wrapped in a black plastic carry bag and kept in the black bag which was kept in front of the meter of the Royal Enfield motor cycle bearing display no- WB 74 BJ 5198 found in the joint possession of the detained persons namely Md. Hasanul and Fatema Begum is weighted 305 grams. And after weighting the transparent plastic packet which was wrapped in a black plastic carry bag and kept in the black bag pack styled as Duck back which was found from the possession of detained person namely Ikbal Hossain is weighted 568 gram. Thus, a reasonable belief having been formed that an offence has been committed in contravention of the NDPS Act and that recovered articles were liable to be confiscated by the NDPS Act. Accordingly, I had seized following articles:

- (i) One transparent plastic packet containing suspected to be brown sugar weighing 305 (three hundred and five) grams and marked as 'Exhibit- A'. from the joint possession of Md. Hasanul and Fatema Begum.
- (ii) One black colour plastic carry bag containing Exhibit-A and marked as 'Exhibit- B'. from the joint possession of Md. Hasanul and Fatema Begum.
- (iii) One black colour bag having two compartments styled as RADHIKA HYDRAULICS containing Exhibit-B and marked as 'Exhibit- C'. from the joint possession of Md. Hasanul and Fatema Begum.
- (iv) One transparent plastic packet containing suspected to be brown sugar weighing 568 (five hundred and sixty eight) grams and marked as 'Exhibit- D'. from the possession of Ikbal Hossain.
- (v) One black colour plastic carry bag containing Exhibit-D and marked as 'Exhibit- E'. from the possession of Ikbal Hossain.
- (vi) One black colour bag pack having three compartments styled as Duckback containing Exhibit-E and marked as 'Exhibit- F'. from the possession of Ikbal Hossain.
- (vii) One Royal Enfield Meteor 350 motor cycle brown and black colour having display no- WB 74 BJ 5198 and marked as 'Exhibit- G'. from the joint possession of Md. Hasanul and Fatema Begum.
- (viii) One blue and black colour YAMAHA R-15 motor cycle bearing display no- WB 66 AP 5511 and marked as 'Exhibit- H'. from the possession of Ikbal Hossain.
- (ix) One dark green colour keypad ITEL mobile phone having IMEI No- 358161167793080/98 and bearing Airtel sim having no- 8116599108. from the possession of Fatema Begum
- (x) One Reddish colour Oppo F 25 pro 5G mobile phone having IMEI No- 860600070850652/645 and bearing Jio sim having no- 9609089045. from the possession of Ikbal Hossain.
- (xi) One Golden colour Vivo V-40 e mobile phone having IMEI No- 866729078235758/41 and bearing Airtel sim having no- 9800200724. from the possession of Md. Hasanul.

under proper seizure list duly prepared by me in presence of independent witnesses and Sri. Sajal Roy inspector of police, O/C NBMC OP under Matigara PS, Siliguri Police Commissionerate who acted as Gazetted officer. I also took signatures of the witnesses, the accused person and Gazetted officer and submitted my signature as seizing officer. Copy of the seizure list was given to the detained persons.

Thereafter, 305 (three hundred and five) grams suspected to be Brown Sugar, 568 (five hundred and sixty eight) grams suspected to be Brown Sugar, both the black colour plastic carry bag, the black colour bag having two compartments styled as RADHIKA HYDRAULICS, one black colour bag pack having three compartments styled as Duckback, one Royal Enfield Meteor 350 motor cycle brown and black colour having display no- WB 74 BJ 5198 and one blue and black colour YAMAHA R-15 motor cycle bearing display no- WB 66 AP 5511 have been properly marked and labeled. Took signature of witnesses and accused persons in the label in presence of the Gazetted officer.

I then arrested the above noted accused persons after informing them the ground of arrest for the possession and carrying of contraband Narcotic drugs under the NDPS Act and issued an arrest memo to them accordingly, duly signed by the accused persons and the witness and the lady constable in case of the arrest memo of the lady accused.

The entire process of Search, seizure, Label, Seal and arrest were done in between 13:35 hrs to 15:45 hrs. The entire process of search, seizure, sealed and labeled under the supervision of Sri. Sajal Roy, Inspector of Police, O/C NBMC OP under Matigara PS, Siliguri Police Commissionerate acted as Gazetted officer and video graphed of search and seizure conducted through the camera of Somnath Chatarjee, S/O- Sushil Chatarjee of Aurobindo Pally, Gokhel Road, W/No. 22, PS- Siliguri, Dist- Darjeeling in compliance with the Order of Hon'ble High Court, Kolkata.

Under the above noted fact and circumstances you are requested to kindly lodge a FIR under proper section of law and arrange for its investigation against accused persons namely 1] Ikbal Hossain (M/35 yrs approx), S/O- Lt Md. Abdul Malek of Kashim Bazar, PO- Bangitola, PS- Mothabari, Dist- Malda (not verified), 2] Md. Hasanul (M/34 yrs approx), S/O- Md. Bablu of Sukanta Pally near Gas godown, PO- Pradhannagar, PS- Matigara, Dist- Darjeeling (not verified), 3] Fatema Begum (F/30 yrs approx), W/O- Md. Hasanul of Sukanta Pally near Gas godown, PO- Pradhannagar, PS- Matigara, Dist- Darjeeling (not verified) and others involved in this racket.
