Sir,

With due respect, I am producing herewith 01 (one) arrested accused person namely Pradip Chawhan (38yrs), S/O- Lt. Kanai Chawhan of Lal pul, Baniakhari, TripaliJote, PO+PS- Matigara, Dist- Darjeeling and 12 (twelve) bottles of Himalayan TukTuk each bottle containing 500 ml and in total 7.200 Literas seized articles. The ground of arrest duly been communicated with him.

I, ASI Bikash Roy, of Matigara PS, SPC under your kind control beg to state that on 12.06.2025 during special evining patrolling van duty, I received a secret source information that one person as noted above is selling liquor illegally from his shop located at Lal pool, Baniakhari, TripaliJote, PO+PS- Matigara, Dist- Darjeeling. Accordingly, myself along with ASI Pema Dorjee Sherpa, C/868 Sujal Roy, C/219 Sanatan Chitrakar and C/523 Sanjit Kundu all are of Matigara PS, SPC left for Lal Pul, Baniakhari, TripaliJote under Matigara PS to work out the information in hand. At 18:45 hrs we arrived at Lal Pul, Baniakhari, TripaliJote in the shop of the above noted arrested person and as per indication by the source, I apprehended the above noted person in red hand who was selling liquor from his shop. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that he is selling liquor from his shop located at Lal Pul, Baniakhari, PS- Matigara, Dist- Darjeeling for his wrongful gain. On being search his shop, the above noted liquor were recovered. On demand he failed to produce any valid documents/license in respect of store/sale of the liquor which were recovered from his shop. Accordingly, I seized the above noted liquor which were found from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of search, seizure and arrest. The whole process of search, seizure, label & arrest was made in between 18:55hrs to 19.10 hrs on 12.06.2025 under videography. Videography done by C/219 Sanatan Chitrakar.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Pradip Chawhan (38 yrs), S/O- Lt. Kanai Chawhan of Lal pul, Baniakhari, TripaliJote, PO+PS- Matigara, Dist- Darjeeling and arrange for its investigation.
