

Subject: Request for Registration of General Diary Entry concerning Theft of CCTV camera from Government Premises.

Respected Sir,

I, the undersigned, Sony Tamang, presently serving as the Purchase Officer at the Gossainpur G.P. Office- Centralized Procurement Camp (CPC), under the Department of Food and Supplies, Government of West Bengal, most respectfully submit the following for your kind perusal and immediate necessary action:

That a CCTV surveillance camera had been duly installed at the front gate of our said office premises, serving the purpose of maintaining security and surveillance over government property and ensuring safety compliance for official ingress and egress.

That, on the morning of 09.06.2025 at approximately 9.30 am while reporting to duty, I discovered that the said CCTV camera was found to be missing from its designated installation site. Upon primarily inspection and internal inquiry among office staff and the surrounding vicinity, I have reason to believe that the said CCTV unit has been unlawfully and deliberately removed and stolen by unknown miscreants, with malicious intent.

That, despite my efforts to investigate the immediate area and question those present, no useful leads have been emerged thus far.

Accordingly, I humbly request your good office to register the aforesaid facts under the General Diary of your police station and kindly initiate appropriate inquiries and proceedings in accordance with law. An acknowledgement copy of the GD entry may kindly be issued for our official record and reference.
