Sir,

With due respect and humble submission, I, SI Sailesh Subba of Bhorer Alo P.S, SPC after producing one arrested accused person namely Biraj Biswas (37) s/o Bijay Biswas of Gander More, Bhutki, PO Balam, PS Bhorer Alo, Dist. Jalpaiguri and the following seized articles under proper seizure list viz:

i] Ten (10) sealed Bottles of "HAYWARDS 5000" Premium Strong Beer each bottle containing 650 ml when packed and labelled and marked as "Exhibit-A" out of which one Bottle is taken as Sample and marked as "Exhibit-A1".

ii] Six(06) Bottles of BAZIGAR 70UP IML (India Made Liquor) each bottle containing 300 ml when packed and labelled and marked as "Exhibit-B" out of which one Bottle is taken as Sample and marked as "Exhibit-B1".

iii] Three (03) Bottles of Pet Bottle Choice Grand Whisky each bottle containing 180 ml when packed and labelled and marked as "Exhibit-C" out of which one Bottle is taken as Sample and marked as "Exhibit-C1".

would like to lodge this written complaint to the effect that today on 12.06.2025 at about 13.20 hours, I along with force while performing my special van duty under Bhorer Alo Police Station vide Bhorer Alo PS GDE No. 424, Date: 12.06.2025 received a source information that one Biraj Biswas of Bhutki Gander More is selling illicit liquor at his shop under Bhorer Alo PS. The matter was informed to Officer-In-Charge, Bhorer Alo PS over phone and as per his kind order myself along with force left for Gander More to verify the said information in hand.

At about 13.30 hours I along with force reached at Gander More and being shown and identified by the source I along with force held raid at the shop of Biraj Biswas and managed to apprehend him. Further in presence of available witnesses I, along with my accompanied team searched his shop and found the huge amount of above noted seized liquor from his possession.

During enquiry the accused person is identified as Biraj Biswas (37) s/o Bijay Biswas of Gander More, Bhutki, PO Balam, PS Bhorer Alo, Dist. Jalpaiguri and on further enquiry he could not produce any valid documents in respect of the above noted seized articles. On being asked he stated that he has been involved in selling and possessing of illicit liquor in his shop without any valid license since long for his illegal gain. The apprehended accused person Biraj Biswas has violated the norms of Bengal Excise Act. Hence, I seized the above mentioned liquor under proper seizure list after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 12.06.2025 in between 13.40 hours to 14.05 hours.

I, therefore pray before your good self that a specific case under proper section of law may kindly be initiated against the arrested accused person namely Biraj Biswas (37) s/o Bijay Biswas of Gander More, Bhutki, PO Balam, PS Bhorer Alo, Dist. Jalpaiguri and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
