Darjeeling under arrest along with the following articles under seizure viz :- (i) one nylon bag containing 20 bottles of HIMALAYAN GOLD 60 Up, containing 600 ml each bottle i.e total 12 ltrs marked as exhibit "A" out of which one bottle of the same taken as sample for examination

I, ASI Jagannath Roy of Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted accused person namely Tapash Bhattacharjee (M/45) S/O Late Tulshi Das Bhattacharjee of Baghajatin Colony, W/N 02, P.S. Pradhan Nagar, Dist. Darjeeling to the effect that on 12/06/25 at 17.35 hrs in course of my RT mobile Van duty (K-30) I received a specific source information that one person is standing at a open place at Himachal Colony under Pradhan Nagar P.S with huge quantity of illegal liquor without any valid documents and waiting for his designed customers to sell these liquor chiefly for his wrongful gain . Accordingly, I informed the matter to duty officer of P.S to diarize the information and it was diarized vide. Pradhan Nagar PS GDE No 703 dated 12.06.25 and informed the fact to you over telephone. Subsequently, being directed by you myself along C/1478 S. Saha and C/473 A. Sarkar went to Himachal Colony under Pradhan Nagar PS, Dist.- Darjeeling by RT Van with investigation kits to verify the veracity of the information. At around 17.50 hrs we arrived at Himachal Colony and contacted with my source who informed me about the place where the above noted person was waiting with illegal liquor. Then, I along with force proceeds towards the place but seeing the police van the aforesaid person tried to flee away but we managed to detain him with a nylon bag. On interrogation he disclosed his identity as noted above and on search the above noted illicit liquor recovered from his possession. On demand he failed to produce any valid or supporting documents for selling and storing of such illicit liquor. On further interrogation he stated that he is involved in respect of possessing of liquor. On further interrogation he revealed that he is running such kind of illegal business of selling illegal liquor since long for his wrongful gain. Then, I seized and labeled one nylon bag containing 20 bottles of HIMALAYAN GOLD 60 Up, containing 600 ml each bottle with proper seizure list from the possession of accused Tapash Bhattacharjee after observing all sorts of formalities on the spot for violation of the norms of the Bengal Excise Act and arrested him u/s 35 BNSS informing him the ground of arrest. The whole process of search and seizure was made in between 18.04 hrs to 18.16 hrs at the spot under the coverage of

Therefore, I pray before your good self that a specific case may kindly be initiated against Tapash Bhattacharjee (M/45) S/O Late Tulshi Das Bhattacharjee of Baghajatin Colony, W/N 02, P.S. Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
