Sir,

With due respect, I am producing herewith the following seized articles viz :- (i) One papermade cartoon containing twenty (20) bottles of "HIMALAYAN GOLD 60 UP India made liquor containinf 600ml. each I,e (20 x 600ml.= 12ltrs) Marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and Marked as exhibit "A1" (ii) One white colour plastic carry bag containing six (06) bottles of "BAZIGAR 70 UP India made liquor containing 300 ml. each i,e (6 x 300ml. = 1.800ml.) marked as exhibit "B" out of which one bottle of the same taken as sample for examination and Marked as exhibit "B1" and (iii) One white & metallic grey colour "YAMAHA Fascino scooty having displaying No. WB 74 AT 5235, Marked as exhibit "C".

I SI Rajiv Subba S/O Basanta Subba of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the owner of vehicle having registration No WB 74 AT 5235, to the effect that on 12.06.25, at 19:00hrs I received source information that one person is possessing a huge quantity of illicit liquor from Matigara and diliver the same at different places, under the jurisdiction of Pradhannagar Police Station, carrying the same on foot rest of his scooter and inside the dicky of his scooter having registration number WB 74 AT 5235, for selling the same to his design customers, for his wrongful gain. Today he would delever his consiment of illicit liquor to his customer at Gate bazar under Pradhannagar PS, Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No. 707 dated 12.06.25 and informed the matter to you. As per your kind order and direction, I along with SI Goutam Mallick, ASI Prabal Sarkar and force, all of Pradhan Nagar PS left Gate Bazar under PS- Pradhan Nagar, Dist- Darjeeling to work out the information with investigation kit by Govt vehicle. I briefed all the Police personnel sharing the information in hand and briefed them properly.


On arriving at near Gate Bazar, I contacted with my source and being identified by the source, from a considerable distance I noticed that one person was standing at near railway track with one scooty having registration number WB 74 AT 5235, and selling liquor gnrnally in public place to his design coustomer from his scooty. Accordingly, we proceeded towards him but seeing police personnel proceeding towards him, he managed to flee away from the spot by taking advantage of railway track but he left his scooty with its key on the spot. On searched the scooty the above noted illicit liquor was recovere. During local enquiry it could be revealed that the owner of the scooty is running such type of illegal business of selling illicit liquor without any valid documents for his wrongful gain. As the owner of the scooty has violated the norms of Bengal Excise Act, further I seized the above noted articles under proper seizure list in presence of witnesses and brought to the PS to proceed further legal procedure. The whole process of search and seizure was made under the coverage of video graphs in between 19:35 hrs to 20:00 hrs at the spot as per norms of BNSS.


Therefore, I pray before your good self that a specific case may kindly be initiated against owner of scooty under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
