Subject: Urgent Request for FIR – Attempt to Murder, Acid Attack, Physical Assault, Sexual Harassment, Criminal Intimidation, and Public Misconduct

Respected Sir/Madam,

I Lalita Choudhary D/O Shivkumar Choudhary writing this letter to file a formal and urgent complaint regarding a heinous and violent attack on my family members we are residing in Santoshi Nagar, Ward No. 5.

On Friday, a serious and unprovoked incident occurred involving Mr. Kamal Sahni, his wife, mother, and Father

Attempt to murder, Attempt to commit acid attack, Physical assault and grievous injuries, Sexual harassment and outraging the modesty of women by tearing the Night Dress, Verbal abuse and obscene behavior in public, Criminal intimidation and threats to life, Public nuisance and possible drug abuse.

I and my sister-in-law were standing outside their home during a power outage. At this moment, Mr. Kamal Sahni, without provocation, approached them and used highly abusive, vulgar, and obscene language in public as he was drunk. The abuse was deeply offensive and targeted at their dignity as women.

After learning about the incident, my brother visited the family and stayed overnight for their protection. While he was walking outside with his son, Mr. Kamal Sahni again confronted him, hurled abuses, physically pushed him, and injured the child. In an act of self-defense, my brother pushed him back and slapped him.

At this point, Kamal, who appeared to be under the influence of drugs or intoxicants, initiated a full-blown physical assault. He called a group of friends and relatives from Bagrakote, who

arrived armed with knives, stones, and other dangerous objects. Together, they attacked the family with clear intent to kill.

I was sexually assaulted, my clothes were torn by Kamal, and I was scratched on the face by Kamal's wife mathematical and the second se Kamal's wife, mother and father.

My sister in law was physically harassed and touched inappropriately during the attack.

The attackers tried to throw acid on my Father. They were seen carrying a container suspected to contain acid, which they attempted to use on him. Fortunately, the acid missed, but the intention was clearly to cause life-threatening injuries and disfigurement.

Multiple family members sustained visible injuries, for which we have obtained medical reports.

Initially, we did not approach the authorities due to fear of retaliation and financial constraints. However, Kamal Sahni has now taken advantage of our silence and filed a false case to suppress the truth and manipulate the narrative.

Given the grave nature of these crimes, I humbly request you to immediately register an FIR against the following individuals: Mr. Kamal Sahni, His wife, His mother, And His father
