- 2. 07 (Seven) Nos of sealed Bottles of Indian made Liquor Kachi 70' up each bottle 300 ml , Marked as Exhibit-B from which 01 bottles taken as sample for examination Marked as Exhibit-B1.

I am submitting a written complaint against the above noted accused person to the effect that today on 12.06.25 myself along with force performing morning PC Party mobile Van duty,. I received source information that one person was selling Liquor illegally from his shop at South Santinagar, Jabravita near Under Pass, under New Jalpaiguri PS, Dist.- Jalpaiguri to its customers without any valid license. Accordingly myself along with C/1462 Sajan Tamang, VP – 08 Lakhan Roy, VP-13 Jamirul Islam all of NJP PS, SPC for South Santinagar, Jabravita area to verify the veracity of information. On arrival at the spot it was found that one person mentioned above was selling liquor illegally from his shop at South Santinagar, Jabravita area, under New Jalpaiguri PS to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above.
