Respected Sir,

I, Aliza Das, D/O Sri Biplab Das and Smt. Shilpi Das, student by occupation, resident of Shaktigarh Road no. 5, near Sailendra Smriti Pathagar Club, Ward no.31 of S.M.C, P.O - Siliguri Bazar, P.S - NJP, Dist - Jalpaiguri, Pin - 734005, do hereby lodge Complaint against the above named persons to the effect:

That there is a dispute going on since long in between my parents and the Promoter namely Sujata Dey one of the Partner of "Maa Sandhya Builders" regarding our landed property and said promoter in collusion with the above noted persons and some more unknown persons is trying to evict us from our landed property.

That in connection with the said matter, on 10/06/2025 at about 7:30 to 8:00 p.m, the above noted persons entered into our shop situated upon the said landed property and started threatening my parents that they will forcefully close our said shop and evict us from the said property and there will be no one to stop them, they started using slang and filthy languages against my parents and by hearing this I, being a daughter could not tolerate and tried to protest against their illegal acts and activities and raised my voice but suddenly the said persons became violent and started abusing me in unprofessional languages and they started uttering unpleasant words towards me with an intention to insult my modesty, and when my parents and I tried to make objection upon their illegal acts they became more furious and physically assaulted me and used criminal force upon me with an intention to outrage my modesty.

That with the intervention of my parents and strong resistance they could not succeed in their heinous act but they left with a threat that they will see me outside my house and they will sexually exploit me, in their words **"TOKE NIYE AMRA KHELBO"**. (the CCTV footage of the incident is Annexed herewith in one Pendrive).

That in view of the above incident I am living in fear for my life and safety, I am a student and for my studies I go outside my home alone and in this situation I am frightened that they may cause harm to me both physically and sexually.

That the above noted persons are known in the locality for engaging in anti-social activities and have created a hostile environment and said Sujata Dey has engaged the above noted persons for the heinous crime against me.

Therefore, I being a helpless lady request before you to investigate into the matter and take strong legal action against the above noted persons at an earliest and oblige me.
