I, Ankita Ghatak, W/o Santanu Roy, resident of Indirapally, Shivmandir, Kadamtala, P.S. Matigara, District Darjeeling. West Bengal, PIN 734011, am writing this to formally lodge a complaint regarding a serious road accident that occurred on 14th June 2025.

On that day, around 10:00 AM, I was on my way to my office riding my scooter. I stopped at a road crossing near Medical More, probably known locally as Sonnasi More, intending to enter the highway. At that moment, a dumper bearing registration number WB 73E 9849, driven recklessly by Mr. Sarath Barman, came from the wrong side of the service road and hit me from behind.

The impact was so severe that my scooter and I got stuck between the front and rear wheels of the dumper. Shockingly, the driver did not stop the vehicle and continued dragging the scooter along with me for some distance. I somehow managed to jump and escape, but the scooter was dragged further. It was only due to the alertness and intervention of nearby passers by that the vehicle was finally stopped.

The local people immediately helped me to stand and took me to a nearby shop for safety. I then called my husband, who arrived at the spot and rushed me to the hospital for medical treatment. I am still under immense trauma and fear following the incident.

This act of gross negligence and reckless driving could have cost me my life and deserves strict action.

Therefore, I request you to kindly register my complaint and take necessary legal action against the driver Mr. Sarath Barman as well as the owner of the vehicle, for their irresponsible and unlawful conduct.

I am ready to cooperate with the investigation and provide any further information or documentation required.
