Sir,

With due respect, I SI Khela Murmu s/o Late Barka Murmu of Ashighar Out Post under Bhaktinagar P.S, SPC do hereby lodge this written complaint against the following accused person and other 15/20 local inhabitants of South Santinagar, Ward no- 36 adjacent area under Ashighar OP to the effect that on 14/06/2025, at approximately 23:05 hrs, while on my special patrol duty under Ashighar OP, I received reliable information about a group of 15 to 20 individuals who have ransacked the home of Nurul Islam situated at South Santinagar, Ward No. 36, near Radha Gobinda Mandir. Nurul Islam is the FIR named the accused person arrested in c/w Bhaktinagar PS Case No. 559/25 dated 13/06/2025, u/s 6 of the POCSO Act.

Responding promptly to the information, I, along with my team, rushed to the scene. During our preliminary inquiry, it became evident that this group of approximately 15 to 20 unknown individuals, had illegally entered Nurul Islam's house around 22:45 hrs. They claimed that Nurul had sexually assaulted a minor girl from a neighboring house, which fuelled their actions. The atmosphere was charged with outrage as the group wreaked havoc within the premises. They vandalized various possessions, smashing a plastic dining table and shattering wooden window frames. The entrance gate was also not spared; it was forcibly torn from its hinges as part of their rampage. In the chaos, several items belonging to Nurul Islam and his family were looted, adding to the destruction and turmoil that engulfed the home that night.

Following verification, I seized the damaged household items and documented the process with proper videography, in the presence of a local witness. Subsequently, I informed my superiors about the situation.

Under the above-noted facts and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against 15 to 20 unknown miscreants and request to arrange its investigation.
