I, Sabana Azmi, Wife of Md. Maksud, resident of Prakash Nagar, Sevoke Road, Siliguri, Ward No.43 of Siliguri Municipal Corporation, Post Office – Sevoke Road, Police Station-Bhaktinagar, District-Jalpaiguri, PIN-734001 would like to inform you that today i.e. 14.06.2024 at around 9.30 p.m. I went to my matrimonial house to collect some of my personal belongings and clothes as since 12.05.2025 I was staying at my paternal house. At times also I used to visit my matrimonial house after 12.05.2025 to collect my belongings as and when required. On each and every occasion Rahuf Ansari, Son of Md. Jahur Ansari used to pass inappropriate comments upon me after seeing me and abuse me using me slangs like Randi, Madarchor and Kutta ka Bacha and also stare at my personal parts.


Today when I went to the house Md Zafir, Son Md Sabir all of a sudden came and snatched the keys from my hand and pushed me and as such I fell down of the floor. Therafter when I stood up Rahuf Ansari, Son of Md. Jahur Ansari appeared in front of me and again pushed me due to which I sustained injuries on my back and shoulders. When I again tried to stand both the persons namely Md Zafir, Son Md Sabir and Rahuf Ansari, Son of Md. Jahur Ansari touched me inappropriately and even grabbed me by my hairs and also grabbed my breasts.

Thereafter my brother namely Sabbu Sanowar Hussain intervened in the situation and somehow or the other helped me to the escape from the clutches of Md Zafir and Rahuf Ansari. In the said episode my brother also sustained serious injuries due to the hurt caused by the aforesaid duo. Both the persons mercilessly hit my brother with fists and blows and my brother starting bleeding from mouth and hands.

Under the aforesaid circumstances I request you to investigate the matter and book the culprits namely Md Zafir, and Rahuf Ansari involved in the crime in accordance with the appropriate provisions of law.
