- [2] Indian Currency Note of Rs. 2,50,000, Denomination as i) Rs 500 X 200, ii) Rs. 200 X 200 iii) Rs.100 X 800 and iv) Rs. 50 X 600.
- [3] One NTORQ Scooty bearing No. WB 74 BA 8652.

I, SI Krishna Parja of DD, SPC do hereby lodged this written complaint against above mentioned accused person to the effect that today on 15.06.2025 at about 20.55 hrs. I received a specific source input that today night, one person namely Bapi Singha will go towards Siliguri from Matigara side in a Scooty bearing No. WB 74 BA 8652 with brown Sugar for delivering the same to the designed customers at Siliguri for his wrongful gain. The matter was diarized in DD, SPC GDE No. 89 , Dtd-15.06.2025 and subsequently, I informed the matter to the ACP, DD, SPC and being directed, at 21.10 hrs myself along with SI Biswajit Ghosh, ASI Sushanta Dey, Const- 562 Utpal Saha, Const-670 Ratan Roy and Const-686 Arup Saha all of DD, SPC left for Matigara - Siliguri Main Road near Chandmoni under Matigara PS with govt. vehicle along with investigation kit to verify the veracity of the information vide DD, SPC GDE no. 90 , Dt- 15.06.2025 and M.C.C No- 147/2025 Date- 15.06.2025.

While going towards Chandmoni, on the way, I requested two independent witnesses namely (1) Vishal Sarkar S/O Bibhash Sarkar of Rangapani, Ranidanga Bazar, PS- Bagdogra, Dist- Darjeeling andf (2) Raja Ray S/O Dilip Ray pof Coolie Para, Ward No. 1, PS- Pradhan Nagar, Dist- Darjeeling in written to remain present as witness during search and seizure if any. They gave their willingness and accompanied with us.

Thereafter at about 21.20 hrs we reached at Matigara - Siliguri Main Road near Chandmoni under Matigara PS and at about 22.05 hrs on being pointed by source detained the above noted Scooty bearing No. WB 74 BA 8652 riding by the above noted arrested person. We disclosed our identity and on question the rider disclosed his name and address as Bapi Singha (M/31) S/O Sudhir Singha of Biswas Colony, near rail gate, PS- Matigara, Dist- Darjeeling . We also disclosed him about the information in hand. On interrogation he confessed that he is carrying Brown Suger in the Dicky of his Scooty and are going towards Siliguri for delivering the same to the designed customers . I gave him option in writing whether he wanted to be searched in presence of a Magistrate or in presence of a Gazetted Officer. He gave his consent for search in presence of a Gazetted Officer.
