Information of violation of the Order passed by the Hon'ble High Court and causing threat to life and property of the Complainant by Ashok Gupta and

Anand Gupta and other unknown miscreants.

Sir.

I Ankit Gupta, Director of Speed Fast Construction Private Limited, having its registered office at City Mall, Sevoke Road, P.O. and P.S. Siliguri, District- Darjeeling-734001, would like to inform you that the Company had filed one Civil Revisional Application as referred herein above before the Hon'ble High Court, Circuit Bench at Jalpaiguri and after hearing all the parties, the Hon'ble Court was pleased to pass the following Order:

> "In the aforesaid facts and circumstances, the bank and the auction purchaser are restrained by an order of injunction from dealing with disposing of and/or changing the nature, character and possession of the property-in-question, particulars whereof are morefully described in this application, till 18th June, 2025.

The bank and the auction purchaser shall be free to urge the maintainability point and seek vacating of the interim order on the next date."

That the said Order was passed by the Hon'ble Court in presence of the respective parties and the parties are well aware of the restraining Order dated 11.06.2025 passed by the Hon'ble Court. Despite the such restraining Order, the men and agents of Indian Bank, the Auction Purchaser i.e., DA3 MALLS LLP, Ground Floor, Shiva Nagar, Beside Darjeeling Bus Stand, Darjeeling More, P.S. Pradhan Nagar, Siliguri-734001 along with several miscreants entered into our land and violated the Order of the Hon'ble Court by trying to change the nature and character by using JCB Machines and also destroyed the agricultural crops that were planted in the said land by us. When I objected to such illegal activities by the Ashok Gupta and Anand Gupta and other unknown miscreants threatened me and other employees of the company including the farmers and labours employed by the Company shouting atop their voice, that if we obstructed them then we shall face dire consequences.

I would like to inform you that the miscreants are continuing their illegal activities in the said land despite being restrained by the order passed by the Hon'ble Court on 11.06.2025.
