Sahani Busty, W.D. No. 43, Siliguri, would like to state that
I ~~have been~~ was married on 25 November 2024 to Surya
Narayan Pandit S/o Ganesh Pandit & Jayanti Pandit at Sri Sri
Siddheswari Kalibari situated Milonpally, Ward No. 9, Dist. Darjeeling.

As per demand of Groom all the required house furniture, utensil
and gold chain of 10gm and ring of 5gm, as well as all the ornaments
of mine was provided by my family. ~~As~~ From Day First I have
been torture by my husband and his whole family members as they
now demanding more cash and ornaments as well as vehicle, property etc.

I want to lodge a formal complaint against my husband and his
family members for subjecting me to mental and physical harassment
over dowry demands. His family members which are involved for harassing
me are his (father) Ganesh Pandit (mother) Jayanti Pandit (brother) Neeraj Pandit
(Sister) Sumita Pandit (brother-in-law) Bikki Sah ~~et al~~ and his (mother's sister,
sister's husband and their son) Ratra Yadav, Rajesh Yadav, Anurag Yadav.

When I failed to meet these unjust demands, they began to mentally torture me and, on several occasions, physically assaulted me. Despite repeated attempts to resolve the matter amicably, the harassment has only increased. I now fear for my safety and mental well-being.

Today 15th June 2025 my husband and his full family mentioned above ~~assaulted~~ assaulted me and move me out of the house when I returned to my own home prakash Nagar. Since it was nearly 12^o mid day my husband with his whole family came to my house and have assaulted ~~my~~ ~~for~~ me again.

So, I kindly request you to ~~for~~ register my FIR and take necessary legal action against the accused.
