Subject: Lodging of FIR against a group of individuals for threatening in the name of community and abetment to suicide

Respected Sir

I, Khushi Khatun, daughter of Late Noor Islam Mia residing at South Shanti Nagar Ward No. 36, Dist Jalpaiguri, , would like to file a complaint against a group of individuals for whom my father got mentally harassed as they threatened in the name of community dominance and social pressure in our area. Their continuous actions and mental torture caused severe emotional distress to my father, which ultimately led him to take his own life on 15 June 2025.

These people created a hostile environment around our home, making my father feel isolated, shamed, and unsafe.

Despite our efforts to protect and support him, the mental burden became unbearable. He was deeply affected by this targeted harassment. My father had no criminal or social misconduct history—he was a peaceful man who couldn't bear such systematic threats and humiliation. Before taking the extreme step, he had verbally and emotionally shared with us that these threats had broken him from within.

I request you to:

Kindly register this complaint as an FIR under the appropriate sections of IPC and ensure the safety and security of our family, as we continue to live under fear.

I am ready to provide any additional information, witness statements, or evidence available related to this case, including any written notes or verbal accounts shared by my father.
