Respected Sir,

In producing herewith one arrested accused person namely Md Kalam (29 yrs) S/O Md Islam of Tikiapara, Matangini-II, PS- Siliguri, Dist- Darjeeling and the following seized articles viz.

- a) One transparent Zipper Plastic Pouch containing Total – 271 grams of suspected to be Brown Sugar – seized from the exclusive and conscious possession of the above noted arrested accused person and marked as 'Exhibit- A'
- b) Cash Rs.450/- (four hundred and fifty) denomination Rs 200x2= Rs 400, Rs. 50x1= Rs.50/- (Total Rs.450/- , Marked as Exhibits-A1, as per seizure list.

I, SI Uday Chakraborty of Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted 03 (three) arrested lady accused persons namely Md Kalam (29 yrs) S/O Md Islam of Tikiapara, Matangini-II, PS- Siliguri, Dist- Darjeeling (Not verified) to the effect that today i.e on 16.06.2025 at about 16.05 hrs received a specific source information that 01 (one) person was busy to sale huge quantity of narcotic substances suspected to be Brown Sugar to his designed customers for his wrongful gain at his house situated at Tikiapara , Matangini-II, Ward No. 28, PS- Siliguri, Dist- Darjeeling . The matter was diarized in Siliguri PS General Diary vide Siliguri PS GDE No.753 Dated- 16.06.2025 and subsequently, I informed the matter to the Inspector-in-Charge, Siliguri Police Station in written and being directed, myself along with ASI Debasish Das, ASI Rabin Lama, Const-160 Soumen Sarkar and LC/ 186 Anisha Biswakarma and LC/696 Shyefali Barman, all of Siliguri PS, SPC and along with investigation kit left for Tikiapara Matangini-II, Ward No. 28 under Siliguri PS by Govt. aided vehicle having Registration No- WB24K/7669, driven by CD-1148 Sudipta Nandi to verify the veracity of the source information. This refers to Siliguri PS GDE No.675 Dated- 14.05.2025 and M.C.C No- 458/2025 Date-16.06.2025. I also informed cameraman namely Ganesh Paswan (52 yrs) S/O Natthu Paswan of Naya Bazar near Samsia Madrasa School, Khalpara ,Ward No. 08, P.S- Siliguri, Dist.- Darjeeling. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to Tikiapara Matanghini-II, Ward No. 28 under Siliguri Police Station , I contacted two persons namely (1)Bipul Ghosh (31 yrs) S/O Late Gopal Ghosh of Tikiapara, Matangini-II, Ward No. 28, PS- Siliguri, Disst- Darjeeling (9832556942) and (2) Raju Sha(42 yrs) S/O Latye Shambhu Sha of Tikiapara, Matangini-II, Ward No. 28, PS- Siliguri, Dist-

Darjeeling, (8695127784) and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with the independent witnesses & cameraman noted above reached at Tikiapara, Maatangini-II under PS Siliguri, Dist- Darjeeling at 16.35 hrs and being pointed by the source able to apprehend the above noted person who was busy to sale Narcotic Substance suspected to be Brown Sugar at his house. Thereafter, we disclosed our identity and informed him regarding the information in hand and stated them that he will be searched in person for the said purpose.

After disclosing our identities, in presence of independent witnesses we had a strong reason to believe that the detained person was carrying narcotic drug in his exclusive and conscious possession & used to supply/ selling the same in the area to his designed customer for his wrongful gain. On being asked they disclosed their identity as noted above and admitted that he has illegally possessed Brown Sugar without any valid license for selling the same to his designed customers. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer and he agreed to be searched in presence of any one of them. In the odd hours, there are scare chance to contact any Executive Magistrate. No other alternative way, I informed the fact to Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station to act as a Gazetted Officer regarding interception of the accused person suspected to be possessed illegal Brown Sugar and requested him to come at Tikiapara, Matagini-II, Ward No. 28 under Siliguri PS to remain present and to supervise the search and seizure as Gazetted Officer.

Accordingly, at 17.15 hrs Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer arrived in full uniform at the spot i.e Tikiapara ,Matangini-II, Ward No. 28 under Siliguri PS and introduced himself as Gazetted Officer. Then, I offered the independent witnesses and the accused person to search our police party as per provision of law but he did not search the police party but as per instruction of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer personal search of our raiding party and our vehicles was conducted but nothing incriminating was found. A nil search list to that effect was prepared in-between 17.35 hrs and 17.55 hrs.

Thereafter in presence Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station (Gazetted Officer) and 02 (two) independent witnesses, I searched the detained person as noted above following all formalities, keeping all decency and recovered a) One transparent Zipper Plastic Pouch containing Total - 271 grams of suspected to be Brown Sugar - seized from the exclusive and conscious possession of the above noted arrested accused person and marked as ' Exhibit- A' b) Cash Rs.450/- (four hundred and fifty) denomination Rs 200x2= Rs 400, Rs. 50x1= Rs.50/- (Total Rs.450/- , Marked as Exhibits-A1,

Further, on demand in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer as well as

independent witnesses the above noted detained person failed to produce any valid documents in support of possessing of such contraband. Being further interrogation, the above noted accused person admitted in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station, acting as Gazetted Officer and the independent witnesses that he have procured the above noted illegal Brown Sugar clandestinely for the purpose of selling the same in high rate to their designed customers for his personal gain by illegal means. He also disclosed that he have been dealing in this business of procuring and selling of Brown Sugar illegally for last few years for his wrongful gain.

Accordingly, I seized the above noted articles from the exclusive and conscious possession of the above noted accused person from his house situated at Tikiapara Matangini-II, Ward No. 28 under Siliguri Police Station Dist- Darjeeling under proper seizure list in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer as well as independent witnesses as noted above. Subsequently, I labelled the seized articles in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer and independent witnesses as noted above. The whole process of seizure and label was made in between 18.55 hrs to 20.15 hrs on 16.06.2025. The whole process of Search seizure is under video graphed.

From the above noted facts and seizure of incriminating articles it is quite evident that the above noted accused person is involved in procuring and selling of Brown Sugar illegally contravening the norms of NDPS Act. Then, I arrested the above noted accused person after observing all the formalities and informing the ground of his arrest and issued necessary Memo of arrest.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused person Md Kalam (29 yrs) S/O Md Islam of Tikiapara, Matangini-II, PS- Siliguri, Dist- Darjeeling and arrange for its investigation.
