In producing herewith following six accused persons namely (i) Parash Jyoti Gogoi (M/35 years), s/o- Lala Gogoi, r/o- 1 No. Miri Hula, Maran, PS- Maran, Dist- Dibrugarh, Assam, (ii) Ananda Sharma (M/35 years), s/o- Purna Prasad Sharma, r/o- Thapa busty, PO&PS- Duliajan, Dist- Dibrugarh, Assam, (iii) Premal Sonar (M/45 years), s/o- Late Harilal Sonar, r/o- 1 No. Saru Pathar, near T.D. Plus Oil Colony, PO- Ananda Para, PS- Duliajan, Dist- Dibrugarh, Assam, (iv) Ajharuddin Sha (M/37 years), s/o- Md. Shafique Sha, r/o- Gurung busty, Upper Road, PO&PS- Pradhannagar, Dist- Darjeeling, W.B, (v) Zahid Khan (M/49 years), s/o- Late Shahid Chowdhury, r/o- 2248/1, Old Ranjit Nagar, PS- Patel Nagar, Delhi and (vi) Chandrip Mahato (M/37 years), s/o- Jiwesh Mahato, r/o- Champasari, Utpal Nagar, PS- Pradhan Nagar, Dist- Darjeeling, W.B (not verified) under custody along with following seized articles:

(viii) One iron made hammer approx length 14" & marked as Exhibit-H.

(x) One realme android mobile phone having IMEI No. 863768071685612/25 and marked as Ex-J.

I, SI Debabrata Kundu of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested six accused persons and other 3/4 absconding unknown miscreants to the effect that today on 17.06.2025 at 00:15 hrs I received reliable source information that some suspect will assemble at Kolkata Road underpass near Gurudwara under Bagdogra PS with a preparation to commit dacoity at Bagdogra area. Accordingly, I informed the matter to O/C Bagdogra PS and diarized the matter in GD vide Bagdogra PS GDE No. 749 dated 17.06.2025. Then as per direction O/C Bagdogra PS, I formed a raiding team consisting SI Binup Mahato, ASI Munna Ahmed, A Amit Lama, VP/01 Anselam Kujur, VP/02 Pradip Roy & CV/386 Kishor Howladar leaded by me. Then at 00:20 hrs as per direction of O/C Bagdogra PS, we left for Kolkata Road underpass near Gurudwara under Bagdogra PS by Govt. vehicle No. WB68Q/6401 to work out the secret source information. This refers to Bagdogra PS GDE No. 750 dated 17.06.2025. On the way we contacted with the night mobile van (K-36) officer ASI Gouranga Das to accompany us. At around 00:35 hrs we reached near Bagdogra Gurudwara and made an ambush there and waited for source indication. Then at 00:35 hrs we parked our Govt. vehicles away from the place. After a lapse of time, at around 01:35 hrs source indicated us the group of suspects. There were a group of about 9/10 suspects. Then, being shown indication by source we started to cordon them from all side. All on a sudden some of them noticed and tried to flee away from the spot. But after hot chase with the help of accompanying Police team we managed to apprehend six suspects there in red-handed at around 01:38 hrs. We searched the place and found independent witnesses but no independent witness could be found available there at the odd hours of
