Subject: Complaint against Mr. Jitendra Prasad, his son Abhishek Prasad, and three unknown persons regarding criminal assault, threats with firearm, and intimidation.

Respected Sir,

I, Mananjay Kumar Pandey, son of Shri Jogendra Pandey, permanent resident of House No. 2, Bye Lane -6, Bakrapara, BasisthaChariali, Guwahati – 781029, Assam, currently residing at 100 C/78, Durga Niwas Dhup Company, Shiv Mandir Road, Purvanchal Pradhan Nagar, Ward No. 2, P.S.- Pradhan Nagar, Siliguri – 734003, hereby lodge the following complaint against Mr. Jitendra Prasad, residing near Brahma Kumari, Nivedita Road, Pradhan Nagar, Siliguri, and others.

Sir, I am a businessman engaged in the supply of coal. Since 2020, I have been regularly supplying coal to Mr. Jitendra Prasad, who owns a brick kiln (ItaBhata) located in Kishanganj, Bihar. In the beginning, he made payments as per the agreed terms. However, over time, he started delaying payments and eventually stopped making any payment altogether. The total amount of outstanding dues now stands at Rs. 51,59,941/-(Rupees Fifty-One Lakh Fifty-Nine Thousand Nine Hundred Forty-One only).

Despite repeated requests and phone calls, he either ignored me or made false promises to pay. Left with no other option, I met him in person on 14-06-2025 near his house at Pradhan Nagar, where he told me to meet him again on 17-06-2025 near khudiram statue, Mallaguri more, Siliguri at around 7:30 PM, assuring that the matter would be resolved.

On 17-06-2025, I went there in good faith and waited. After some time, Mr. Jitendra Prasad arrived in an electric Tata Nexon car along with his son Abhishek Prasad and three other unknown

persons. To my utter shock, instead of paying the dues, Mr. Jitendra Prasad denied owing me anything and all five of them started abusing and threatening me.

When I protested and demanded my rightful payment, they brutally assaulted me. I was slapped and kicked repeatedly. While I tried to take out my phone to seek help, Mr. Jitendra Prasad suddenly pulled out an automatic firearm, forcefully pressed it hard against my forehead, and shouted:

"Dobara paise maanga toh bandook se uda dunga... yahi maar ke fek dunga tujhe, tera laash bhi nahi milega"

I was completely shocked, numb, and terrified. I could feel the cold barrel of the weapon digging into my forehead, and I was certain they were about to kill me. This horrifying act has left me completely traumatised. The accused persons then fled from the spot, leaving me injured and trembling.

Sir, I am living in fear for my life. These individuals are dangerous and influential, and I fear they may attack me again. I am a law-abiding citizen and a businessman trying to recover my hard-earned dues, but instead I have been assaulted, abused, and threatened with death.

Take immediate legal action against Mr. Jitendra Prasad, Abhishek Prasad, and the three unknown accomplices. I request you for my personal safety and security, and that of my family. I am ready to cooperate fully with the investigation and provide any further documents or evidence as required.
