## Respected Mam,

This is to inform you that I, Chanda Sah, daughter of Sri Kameshwar Sah, resident of Samar Nagar, Barttala, near Kali Mandir, Champasari., P.S- Pradhan Nagar, PIN- 734003, got married to one Aakash Gupta, Son of Ashok Gupta, resident of Bhola More, Gas Godown, PIN- 734004 on 31-08-2017 and since then I was living and cohabiting with my husband and his family members at my matrimonial home at Ganganagar, Ward No 05 of SMC, Siliguri, PIN- 734001. That since the very beginning my husband neglected me and tortured me in front of the family members and whenever I tried to seek help from my in-laws, not only did they ignore me but in fact aided to his atrocious acts. That out of the said wedlock, one girl child is born on 24-12-2019 namely Ayesha Gupta, presently aged about 5 years old. That when I was pregnant, my husband and my in laws, did not provide me with proper food or medical assistance. That my daughter born right before the outburst of the Covid-19 pandemic, and during the peak of the pandemic lockdown, my husband and my in-laws put me and my said 3 months old child in a separate small room and refused to provide us with proper food. That seeing my condition during that time my father and mother used to come to my matrimonial and provide us with food.

That after the covid-19 pandemic, my husband took me and my daughter to a separate residence at Bhola More, Gas Godown, PIN- 734004 in the year 2021, where my mother-in-law namely Sri Rani Devi Gupta, Sisters-in-law namely Manisha Gupta, brother-in law namely Rabi Gupta also stayed with us. That the torture increased day by day where my husband and my mother-in-law used to beat me with fists and blows and always taunted me for giving birth to a girl child. That during my stay at the said residence, all my gold jewellery were at the custody of my husband and mother-in-law and is still under their custody presently. That on several occasions my brother-in-law used to raise hand at me at his own will and fancy and whenever I sought help from my husband, he not only refused to help me but also encouraged my brother-in-law to do the same. That due to daily torture and beatings, in order to save my and my daughter's life, finding no other solution I came back to my parental home and is currently residing the abovementioned address with my parents since 2022.

It is pertinent to mention that the said Akash Gupta had taken several loans in my name by providing my documents and putting my forged signature in my documents to start a shop. Such loans total amounting to Rs. 1,40,000/- has been sanctioned from several banks which I was unaware about until the bank agents started calling me for repayment of the said loan amount. That when I confronted about the same to the said. Akash Gupta, he threatened me by saying that he wont repay the same. That as a result, I am under great stress and pressure as my CIBIL score has been hampered due to the same. That due to said circumstances my condition has become miserable.

That it is also pertinent to mention here that the said Akash Gupta is in an illicit relation and extra marital relation with one Priti Mandal and has been aiding to his acts and conducts.

That on several occasions, the said Akash Gupta came to my parental home and harassed me in front of my family members and has beaten me with kicks and blows. That when my mother tried to stop him, he abused my mother with abusive languages. That the said Akash Gupta has been calling me from several numbers and has been harassing me in several ways. That all limits were crossed when on 14-06-2025, at around 10.30 P.M. the said Akash Gupta called me and threatened me that he will kill me if he sees me anywhere on road and will take my daughter away. That after the call disconnected, the said Akash Gupta came to my parental home where I am currently residing at, started screaming and pelting stones at my house and started throwing kerosene at the premises and threatened that he will set the house on fire.

That I am under great stress and trauma as I am worried about the safety of me and my family members. Therefore, I pray before your goodself, to take immediate action against the said Akash Gupta (7719124323), my mother-in-law Rani Devi Gupta, sister-in-law Manisha Gupta, brother in law namely Rabi Gupta (8327560746) for the ends of justice.
