I, Sri Abhishek Roy, S/O Jagadish Ch Roy, Station Manager, Customer Care Centre Matigara, WBSEDCL, P.S Matigara do here by lodge this complain empowered by Electricity ACT 2003 (amendment act 2007) to the effect that Sharwan Kumar Sah s/o Raghupati Sah of Siliguri National School at Vill: Tumbajote Beldangi, PO & PS Matigara, Darjeeling has committed use of electricity illegally under section 135 (1) (e) and 138 (1)(b) of electricity Act 2003.

On dated 17.06.2025 at 14.53 hr I along with accompanying WBSEDCL team viz. 1) Bhaben Roy 5.0 S&LP of Darjeeling Regional Office, WBSEDCL, 2) Bijay Lakra, DE & S&LP Darjeeling Regional Office, WBSEDCL 3) CCC, 3 ) Sanjay Ram, H.G T.S.H of Matigara CCC 4) Pradip Biswas , H.G T.S.H of Matigara have entered the premise of Sharwan Kumar Sah and Deblal Hembram S/O Mangal Hembram residing at Tumbajote, PO & PS Matigara, Dist Darjeeling. During inspection it has been found that total amount of 8061.84 (OSD) as on 17.06.2025 is pending as electricity outstanding bill for consumer id 412140656 of SRI DEBLAL HEMBRAM. It is also found that said connection under con id : 412140656 was disconnected for not paying electricity bill on 05.02.2024. At the time of inspection, it came to our notice that said disconnected premise has been reconnected illegally without clearing outstanding dues from unauthorised extension service from premise of Siliguri National School C/O Sharwan Kumar Sah. Accessed load of electricity illegally enjoyed by him is 2.35 KVA. The findings are incorporated in the inspection report prepared at site.

Hence prepare an inspection memo by mentioning all minute details, as observed and also seized the PVC service wire in question after preparing the proper serial list duly signed by witnesses and representative of the premise owner. Supply copies of required documents to the representative for future reference. Remove the PVC service wire from the place after observing all technical formalities. The inspection team left the said premises at 15.05 hrs on date.

So, it is requested that a case under section 135 (1) (e), 138 (1) (b), 150 of Electricity Act may please be registered against Sharwan Kumar Sah s/o Raghupati Sah and Deblal Hembram S/O Mangal Hembram and arrange for its investigation.
