Sub: FIR against SMT Shila Mahato w/o Ganesh Mahato of residing at vill: Kholaibaktari, PO & PS Matigara, Darjeeling under section 135 (1) (e) and 138 (1)(b) of Electricity Act 2003 due to illegal extension of service to a disconnected premise of Sujit Chanda at vill: Kholaibaktari, PO & PS Matigara, Darjeeling and under section 150 of the Electricity Act 2003 against Sujit Chanda at vill: Kholaibaktari, PO & PS Matigara, Darjeeling.

Dear Sir,

I, Sri Abhishek Roy, S/O Jagadish Ch Roy, Station Manager, Customer Care Centre Matigara, WBSEDCL, P.S Matigara do here by lodge this complain empowered by Electricity ACT 2003 (amendment act 2007) to the effect that SMT Shila Mahato w/o Ganesh Mahato of residing at vill: Kholaibaktari, PO & PS Matigara, Darjeeling has committed use of electricity illegally under section 135 (1) (e) and 138 (1)(b) of electricity Act 2003.

On dated 17.06.2025 at 13.35 hr I along with accompanying WBSEDCL team viz. 1) Bhaben Roy S.O S&LP of Darjeeling Regional Office, WBSEDCL, 2) Bijay Lakra, DE & S&LP Darjeeling Regional Office, WBSEDCL 3) CCC, 3) Sanjay Ram, H.G T.S.H of Matigara CCC 4) Pradip Biswas, H.G T.S.H of Matigara have entered the premise of SMT Shila Mahato w/o Ganesh Mahato and Sujit. During inspection it has been found that total amount of 1840.00 (OSD) as on 17.06.2025 is pending as electricity outstanding bill for consumer id 401695810 of Sujit Chanda. It is also found that said connection under con id : 401695810 was deemed disconnected for not paying electricity bill on 23.03.2024. At the time of inspection, it came to our notice that said disconnected premise has been reconnected illegally without clearing outstanding dues from unauthorised extension service from premise of SMT Shila Mahato w/o Ganesh Mahato. Accessed load of electricity illegally enjoyed is 0.580 KVA. The findings are incorporated in the inspection report prepared at site.

Hence prepare an inspection memo by mentioning all minute details, as observed and also seized the meter in question after preparing the proper seizure list duly signed by witnesses and representative of the premise owner. Supply copies of required documents to the representative for future reference. Remove the meter from the place after observing all technical formalities. The inspection team left the said premises at 13.45 hrs on date.

So, it is requested that a case under section 135 (1) (e), 138 (1) (b), 150 of Electricity Act may please be registered against SMT Shila Mahato w/o Ganesh Mahato and Sujit Chanda and arrange for its investigation.
