Respected Sir/Mam,

I, Smt Beli Mandal D/O Hari Gopal Mondal, residing at Deshbandhu pada DBC road, Ward No. 29, PO Siliguri town PS Siliguri district Darjeeling, West Bengal. PIN. 734004, beg to state you that my elder sister Shila Mandal, Shanta Mandal and brother Pankaj Kumar Mandal try to deprived me from the share of my deceased parents property. My deceased father leave behind him a property landed measuring approximately 4 kathas with a teen shade structure 3B.H.K. house, situated at Bhaktinagar, behind pipeline, ward no 35, P.O & P.S Bhaktinagar, Dist- Jalpaiguri. West Bengal and a land measuring about 1.5 katha of pakka house situated at Deshbandhu para DBC road, Ward No. 29, PO Siliguri town PS Siliguri district Darjeeling and in the Deshbandhupara Property my other siblings are reside there and At the time of death of my father, he verbally handed over the Bhaktinagar property to me. From that day I am taking care of the above mentioned property. To protect the property from the stranger or occupier I have constructed the teen shade house for rented purpose. I also mentioned here that due work purposes recently I am staying in vizag city. Taking this advantage now a days Shila Mandal, Shanta Mondal and Pankaj Mandal are trying to occupy the following lands and house forcefully and trying to sell the property without my knowledge. I also mentioned here that the above mentioned accused persons several time visited that Bhaktinagar property and threatened my tenant to vacate the house.

Finding no other alternative way, to the few days ago I came to Siliguri and went to my parents house and but they forcefully restrained me to enter that house and also assaulted me. In this regard I logged a written Complaint against them under Siliguri Police Station. Then I went to another house of my deceased father i.e. situated under Bhaktinagar. I would like to mention here that though the house is constructed by tin shad due to rain fall some part of it has been damaged so today I engaged few labour to construct the damage part but suddenly at about 2 p.m. the Shila Mandal and Pankaj Kumar Mandal came with dare consequences without any reason using filthy languages upon me and also asked the labour to stop the construction work immediately and when I try to defend them by saying I have also equal

right over this property they hit me here and there not only that pankaj mandal torn my wearing apparel and pushed me on my chest as a result I sustain grievous injury on my body. Pankaj mandal also threatened me by saying that I am an advocate you cannot do anything against me and when I started shouting they fled away, not only that with the criminal intentions to make false case against me they came along with pankaj's minor child. The CCTV footage also present of this incidents.

Therefore I request before your please look into this matter as soon as possible and take proper legal action against this incidents as because being a helpless women I have no one to look after and have without my father's house I have nothing to take shelter.
