I, Sri Bijay Lakra, (45), Divisional Engineer(Electrical), S & LP wings of Darjeeling Regional Office, WBSEDCL, 2nd Mile, Sevok Road, PS-Bhaktinagar, Dist-Jalpaiguri, (S/O: Sri Bernard Lakra), do hereby lodge complaint against aforesaid Shri Monoj Bose to the effect that, on 16.06.2025 in course of inspection, myself along with Shri Bhaben Roy, S/O: Late N.C Roy, SO of Darjeeling Regional office, WBSEDCL, Sukanta Talukder, Sr. Office Executive , S/O- Late Santosh Talukder, Shri Subhankar Neogi, Linesman, S/O: Late Swapan Kumar Neogi of NJP Gate Bazar CCC & other technical staff of NJP Gate Bazar CCC had been to the premises of Debasish Das at Nabagram, Ward no. 33, P.S. NJP, Dist: Jalpaiguri at 12.05 Hrs. Prior entry to the premises, a notice was issued in the name of Debasish Das for inspection of the said premises which was received by Monoj Bose, who was introduced himself as the owner of the premises and he is the present user of the existing service connection as Debasish Das had sold the property to Monoj Bose. I arrange to call witnesses from the vicinity but none turned up. However, in presence of the present user of the said premises we conducted inspection.

During inspection it was found that, there has one domestic connection vide consumer id: 412092706 in the name of Debasish Das in the premises, where Monoj Bose, the present user was using electricity illegally for his commercial purpose to run a Grocery Shop. Due to this unauthorized use of electricity WBSEDCL has occur a loss of revenue. On detection of such illegal use of electricity service line was disconnected & meter was dismantled. During inspection load of electricity consumption as observed in the same premises was 3.505 KVA. On being asked, Shri Monoj Bose admitted his guilt for committing aforesaid offence.
