Sub: Prayer for Lodge an F.I.R.

Respected Sir/Madam,

I, Sekh Sajjad, son of Late Mohammad Jun, resident of Netaji Nagar, Colony, Champasari, P.O. - Champasari, P.S. - Pradhan Nagar, Dist. - Darjeeling, Advocate by profession as well as member of the Siliguri Bar Association, beg to inform you that I am Muslim by faith and Islam by religion and I have my chamber at the ground floor of a building namely "Mahanam Residency" situated at 18 Rashbehari Sarani, Hakimpara, P.O & P.S. - Siliguri, Dist. - Darjeeling, it is pertinent to mention here that I am the owner of a flat having 3BHK, at the top floor in the said building, I have let out that property on rent to one Smt. Kanak Prova Chanda where she lives with her cousin sister since 01.06.2025.

Yesterday (i.e. on 10/06/2025) evening I was there at my chamber along with one of my colleagues namely Pankaj Thakur(Advocate), at around 8:20 pm, I got a Phone call from a Mobile No. 6296870496, a person introducing himself as Sekhar Das, directed me to throw out my above-named tenant. Naturally when I asked him regarding the reason behind his such unexpected direction or desire, he started abusing me with utmost filthy languages and also threatened me that if I disagree with him I will face serious consequences. I told him to cool down and requested to come my chamber so that we can sit face to face and talk about the matter.

But he did not come instead kept me calling repeatedly, over those phone calls, he said that Siliguri is a place of Hindu majority and I being a Muslim person can do nothing against him. He told me, he will come to my chamber along with people then

will throw me out from my chamber, he also said that he will come to Siliguri Court and assault me.

When he became more abusive, I felt it necessary to record his call and I did so, I have some part of the voice recording of those phone calls, I am mentioning few of those abusive language here under which was deliberately used with the intention to outrage my religious feeling, he also threatened saying that he is a member of the majority community being Hindu and he can do anything he wants with me I being a member of the Muslim minority community, his comments were intentionally made to disturb the communal harmony between the Hindu and Muslims, I am quoting some of his comments over the phone hereunder:-

- 1. "Hindu koto acche Siliguri te janis kutta ar baccha, toke marbo re Muslim suar er baccha, toke kopabo re....."
- 2. "Toke ja kopabona re Muslim madarchod......"
- "Toke akhon hi tor bari te dhuke pitaye asbo, etc"

He altogether called me seventeen times, subsequently I stopped receiving his calls.

In view of the present circumstances, I humbly request you to take immediate necessary action to catch the culprit and take necessary action against him.
