I, SI. Bhiswadeb Barman serving under your kind disposal filling this written complaint against 1. Bikramjit Mandal, 2. Sudip Bhagat, 3. Sourav Ghosh, 4. Asish Dey Sarkar, 5. Mantosh Paswa, 6. Manna Bhadra, 7. Dhiraj Kr. Jaiswal, 8. Hiranmoy Goswami Maharaj Secretory of Viswa Vidya Dham Trust of Radhakund Vrindavan Mathura, Uttar Pradesh and other 40 to 45 leaders and supporters of BANGIYA HINDU MAHA MANCHA and Viswa Vidya Dham Trust of Radhakund Vrindavan Mathura, Uttar Pradesh to the effect that on 18.06.2025 at 15.05 hrs during my patrolling van duty vide Siliguri PS GDE No. 855, M.C.C No.472/250 I received an information that an unruly mob lead by the leaders of BANGIYA HINDU MAHA MANCHA will arrive at Venus More under Siliguri PS area to demonstrate against present Law & Order scenario of the in and out Siliguri area and some of the disputes between different communities appears in the recent past which has created sensation in the society, also information received that the said unruly mob may raise sensitive slogans which may provoke breach of peace in and out Siliguri PS area. Accordingly, I informed the matter to I/C Siliguri PS and ACP East - I, SPC over phone and rushed to Venus More. Accordingly as directed by IC, Siliguri PS myself along with SI. Gopal Mandal, SI. Rakesh Tamang, C/1404. Ujja! Singha, C/1406. Biman Barman, C/1424. Ashok Barman, C/1563. Joy Chhetri, LC/1313. Mili Roy, left PS for Venus More to avoid any adverse situation and to maintain law & order over the area.

At around 17.15 hrs I found a group of unruly mob consisting approx 40 to 45 persons coming towards Venus More from Panitanki More Side through Bidhan Road by blocking the free flow of traffic, in the rally one car having number WB 74 BN 8458 was also took part, along with them they were carrying posters and banners and they raising slogans with wards like "JIHADI" indicating to a minority community. On arrival at Gostho Pal more, myself along with force asked to stop them also asked for the permission copy for holding the rally but they failed to produce the same, accordingly I stated them that without having any valid permission they carrying out this rally illegally but they pay no heed to my words and violated the direction of on duty Police officers and I tried to make them understand that as this is the pick hours of traffic movement and school students are returning from their institutions and it creating a great convenience on their way to home, also I requested them not to raised slogans intentionally using sensitive wards indicating to a particular community as it may cause to break the public peace at Siliguri area. In between this one person introduced himself as Hiranmoy Goswami Maharaj Secretary of Viswa Vidya Dham Trust of Radhakund Vrindavan Mathura, Uttar Pradesh along with his supporters started provoking the persons who participated in the said rally without any permission and also became engaged in hot altercation with Police and the supporters became agitated and continuously raising communally sensitive slogans. Seeing the situation I strongly direct them to control themselves and move out immediately from the road and not to create any chaos in the public place and by convincing the persons I removed them from the middle of the road. After that we managed to disperse the leaders and supporters of BANGIYA HINDU MAHA MANCHA from Gostho Pal More, Bidhan Road and took control of the situation.

therefore my humble request before you that a specific case may kindly be initiated against 1. Bikramjit Mandal, 2. Sudip Bhagat, 3. Sourav Ghosh, 4. Asish Dey Sarkar, 5. Mantosh Paswa, 6. Manna Bhadra, 7. Dhiraj Kr. Jaiswal, 8. Hiranmoy Goswami Maharaj Secretory of Viswa Vidya Dham Trust of Radhakund Vrindavan Mathura, Uttar Pradesh and other 40 to 45 leaders and supporters of BANGIYA HINDU MAHA MANCHA and Viswa Vidya Dham Trust of Radhakund Vrindavan Mathura, Uttar Pradesh for illegally and unlawfully assembled in the middle of the Gostho Pal More, Bidhan Road under the jurisdiction of Siliguri PS for assemble unlawfully, using wards insulting a specific group of people, obstruct and restraining and disobeying the direction of public servant and arrange for it's investigation.
