Md Mukhtar Hussian also a ragpicker started an altercation with me over the matter of picking of rags, in Bidhan Market.

That I am a 60 year old person with severe health problems and when the altercation started I was unable to properly reply or reciprocate Akbari Begum's hostility. That I returned home that day empty handed and hurt as she had snatched my rags wrongfully from me and in the process I received minor hurts. In a while her daughter namely Baby Hena entered my house and started hauling ,beating, punching and kicking me couple of times. Luckily it was time for my daughter(Mariyam Khatun) and son in law (Md Akbar) to return home . My daughter was trying to save me up but even my daughter was beaten, her hairs snatched and pulled, and dragged by said persons. When my son-in-law interfered to stop the fight even he was badly beat up by said persons and also started throwing things of my house.

That again on 17.06.25 when my daughter(Mariyam Khatun) came to my residence above mentioned address to provide me food as I cannot prepare my own, she was wrongfully restrained by Said persons Namely Akbari Begam and Baby Hena and they did not allow her to enter her own residence, and also abusing my Daughter in filthy language.
