**Sub:** - Complaint against Theft of ancillary equipment(s)/material(s) by unknown person/ persons from our Telecom Site at the Land of MRS Jaya dey wife of Mr. Goutam dey at Ektiashal more (Woodland park), District- Jalpaiguri PIN-734006 West Bengal ("Telecom Site").

Dear Sir,

I, **Sri Pranab Ghosh** son of L/T M ghosh, aged about 38 years, working as Technician for Telecom Circle -ROWB, being authorized by GTL Infrastructure Ltd. hereby lodge this Complaint against unknown person/ persons for theft of 70 sqmm flexible copper cable 24 meters. material(s) as mentioned below and owned by GTL Infrastructure Ltd. installed at the aforesaid Telecom Site, having site ID. WEB/GNT/H/06146 and site name 'EKTIALSHAL MORE'.

1. We, GTL Infrastructure Limited ("GIL/Company"), are a company incorporated and registered under the Companies Act, 1956, having its Registered Office at 7<sup>th</sup> Floor, Building no. A, Plot No. EL 207, MIDC, TTC Industrial Area, Mahape, Navi Mumbai - 400710, Maharashtra, and Circle Office at 7<sup>th</sup> Floor, Shaila Tower, Plot - J1/16, Block - EP & GP, Sector- V, Saltlake, Kolkata-700091.
2. A Lease Deed/License Agreement dated 13-Oct-2008 was executed between GTL Infrastructure Limited and MRS JAYA dey wife of Goutam dey ("Landlord"). After the execution of the said Agreement, a tower was constructed on the land of the said Landlord. As such the said Site is presently in possession of GIL and the Tower erected thereupon with all of ancillary equipments is/are owned and is possessed by GIL. The Telecom Operators to whom the Mobile Tower is given for erecting their equipment / instrument have also fitted their equipment / instrument upon the said Mobile Tower.
3. We submit that, on 16-06-25 time approx. 7:00 am, our Company (GIL) representative visited the aforesaid Site and during that routine visit and inspection it was found that 70 sqmm flexible copper cable 24 meters of Materials [hereinafter referred to as "Theft of Asset(s)"] has been stolen from the said Site. Upon enquiry it is understood that the said act of theft of Asset(s) at our site is caused by some miscreant(s) i.e. unknown person/ persons. The said ancillary equipment/material(s) as mentioned above are the legitimate asset belonging to GIL and the current Written Down Value (WDV) of the said asset till the date of theft is **Rs. 7200/-** as morefully mentioned in Annexure-A written hereunder.
4. Due to this intended unlawful act of theft, of the said Assets at the said Site by these miscreants/ unknown person/ persons, the Company has faced and is facing huge financial loss. It is pertinent to mention that the Company has/had never any intention to remove or dismantle the said equipments from and/or at the said Telecom Site nor Company has authorized any third party for the same.
5. We would like to inform you that this criminal act committed by these miscreants/unknown people is a serious offence and is punishable under various Section 303(1), 303(2), 323, 324(1), 329(1), 329(3) of BNS, 2023 (Bharatiya Nyaya Sanhita 2023) and read with Section 42 of Telecommunication Act 2023 have been committed in the territorial jurisdiction of this Police Station, thus the present complaint.

In view of the aforesaid scenario, we hereby request you to kindly intervene in the matter and provide necessary support to the Company as deemed fit by your good office. I would therefore request you to kindly register the GDE and initiate early investigation in the said matter.
