I, Sub-Inspector Paresh Barman of New Jalpaiguri Police Station, Siliguri Police Commissionerate, do hereby lodged this written complaint as suo-motto against the 25/30 unknown persons of Thakur Nagar, Eastern Bye Pass, , near Bhabesh Patrol pump PS. NJP Dist. Jalpaiguri to the effect that today i.e., on 18.06.2025 at 09.30 in course of performing QRT duty at eastern by pass area vide GDE NO 915/25 , received an information from Duty Officer SI Kaji Rejaul Karim of NJP Ps that a road blocked was going on at near Bhabesh Patrol pump , Eastern Bye pass Road PS NJP Dist. Jalpaiguri . As soon as I along with other officer and force rushed to the spot and found 30/35 unknown persons was trying to enforce a Road Blocked by stopping traffic flow of vehicles at Eastern bye Pass road, near Bhabesh more demanding arrest of all miscreants immediately in c/w with New Jalpaiguri PS Case no which had taken place at thakur nagar area on 17-06-2025.

Accordingly I along with other officers and forces asked them not to halt the movement of traffic flow due to which there was a huge traffic jam and the passengers were facing hardship to reach their concern destination. But they did not pay any heed to my legal instructions. I also announced the gathering to be unlawful and asked them to disperse peacefully. But in spite of my repeated request/ instruction the unruly mob who had been performing road blocked there since half an hour, became agitated and violent and also started to threaten the Police. I tried to explain the unruly mob who had staged road blocked at Bhabesh more, Eastern bye pass Road under Ps NJP Dist. Jalpaiguri but they did not pay any heed to the announcement. Finding no other alternative and to avoid commission of further cognizable offence, myself and forces chased the unruly mob, but in the process of arresting, all the persons fled away from the spot and later the Vehicular traffic flow became normal.

Under the above circumstances I therefore pray a specific case may kindly be registered against the unknown persons and arrange for its investigation.
