- l, SRI KUNAL BANSAL, Son of Sri Vikash Bansal, one of the partners of SKYMOUNT BEVERAGES LLP, having its registered office address at 744, Village Kanchanbari, Mouza Binnaguri, Fulbari Hat, in the District of Jalpaiguri 734015, would like to lodge an F.I.R., stating as follows:
 - That our company SKYMOUNT BEVERAGES LLP deals in the business of manufacturing and supplying of packaged fruit juice drinks and is in this business since past many years.
 - 2. That on 6th June, 2025 we have loaded a truck having number. RJ40GA6968 of packaged fruit juice drinks, bearing invoice number SBL/236/2025-26, e-way bill number being 891539271757, amounting to Rs. 3,55,700/- (Rupees Three Lakh Fifty Five Thousand Seven Hundred) only which was to be delivered at Buxer, Bihar, to SANTOSH ENTERPRISES, having their registered address at Mathiya Mod, Badka Nuaon, Chausa Road, P.O. Central Jail, Buxer, Bihar 802102. That our company has been doing business with Santosh Enterprises since a few years.
 - 3. That the packaged fruit juice drinks were transported by us through our regular transporter namely, Ashok Yadav having mobile number 9832314275, who used to arrange the truck or vehicle at our warehouse, and we used to load the same with the goods required to be supplied.

- 4. That on 6th June, 2025, the aforesaid truck having vehicle number RJ40GA6968, was engaged by the said transporter to us. Since, we had to transport the packaged fruit juice drinks to Santosh Enterprises, Buxer, we accepted his offer and Ashok Yadav sent us the aforesaid truck for the purpose.
- 5. The details of the truck/vehicle which were provided to us are as follows:
 - a. Vehicle/Truck Number RJ40GA6968
 - b. Owner of the Vehicle/Truck Ayub Khan
 - c. Contact details of the owner 7688908352
 - d. Name of the Driver Shahbaz Khan
 - e. Contact details of the Driver 6307690104
- 6. That the packaged fruit juice drinks were loaded on the truck and it left our warehouse on 6th June, 2025 at around 07:30 pm. It is imperative to note here that the normal time frame to deliver goods from Siliguri to Buxer is two to three working days.
- 7. That the details of the truck and driver were given to Santosh Enterprises in Buxer. Time and again when they tried establishing contact with the driver, the driver initially said that they will reach soon and later kept on making excuses. Thereafter, the driver turned off his mobile phone after which no contact could be established between the driver and Santosh Enterprise. Subsequently, I have also tried to contact the truck driver, but no contact could be established with him.
- 8. That having no other alternative, on 11.05.2025, I contacted the transporter and askedhim about the vicinity of the truck. The transporter informed me that the driver of the vehicle is inaccessible and as such he gave me the contact details of the owner of the truck/vehicle. When I enquired the owner of the vehicle about the whereabouts of the truck/vehicle, to my utter dismay and shock, he informed me that the truck was unloaded at Kanpur, thus, it had reached its final destination.

9. That on questioning that the goods were to be delivered in Buxer and not Kanpur, the owner of the vehicle/truck stated that one Naseem Khan, having mobile number 6394411918 informed the same of the blick truck is the formed the same of the blick truck is the same of the bline truck is the same of the blick truck is the same of the blick

6394411918, informed the owner of the vehicle / truck that the goods are to be delivered

at Kanpur.

It is worthy to note here that Ashok Yadav said to me that it was Naseem Khan who

communicated with Ashok Yadav, and requested him to load the aforesaid truck.

Additionally, Naseem Khan has no say in business of Skymount Beverages LLP or

Ashok Yadav.

10. That I am afraid that Ayub Khan (owner of the truck/vehicle), Naseem Khan (the middle

man) and Shahbaz Khan (the driver of the truck/vehicle) in collusion with each other,

have with a malafide intention stolen my goods and have further misappropriated the

goods by selling it to a third party with an ill-motive of gaining financial benefits.

11. That therefore I request before your good self to take necessary action against the said

miscreants and help us recover our goods from them.
