Sir,

I Sri Avejit Kundu, S/o Sri Ashok Kundu, practicing Advocate and member of Siliguri Bar Association, do hereby inform you that I along with my Ld Colleague Adv Koustav Sen was standing in front of the main gate of Siliguri Court at about 2:40 p.m at that relevant time the above named miscreant namely Md Ali @ Sunny along with another came towards in his motorbike bearing number in a rash and negligent manner and hit us with the bike, thereafter when I raised rebellion they started beating us with fists and blows and Md Ali @ Sunny took out a big knife and tried to stab us with the knife with an intention to kill us, we somehow could prevent ourselves from being stabbed. All the nearby Advocates and parking staffs ran to save us and caught him and saved our life and the other unknown miscreant ran away and absconded. I therefore request your good office to look into the matter and do the needful and book the miscreants as per the law of the land for beating me and for attempting to kill me with a knife.

Please treat this as very urgent and act accordingly.
