Subject:- Written Complaint against Smt Pinki Dutta, wife of Late Dipankar Dutta @ Poltu, resident of Santinagar, Siliguri, District- Jalpaiguri, Contact No. 9734080999.

Dear Sir,

I, Smt. Gargi Roy Nandi, wife of Sri. Ajay Roy, Daughter of Sri. Basudeb Nandi, resident of Satinath Bhaduri Sarani, Rabindra Nagar, P.O.- Rabindra Sarani, Siliguri, District- Darjeeling, West Bengal, PIN- 734006, would like to inform you as follows:-

I got married with Sri. Ajay Roy, Son of Sri. Sudarshan Roy on 01.05.2007 according to Hindu rites and customs and after marriage I started living with my husband at his residence at Satinath Bhaduri Sarani, Rabindra Nagar, P.O.- Rabindra Sarani, Siliguri, District- Darjeeling, West Bengal, PIN- 734006, as husband and wife. It is relevant to mention here that out of the said wedlock one male child, Aritra Roy, was born on 14.10.2008. Previously my husband used to run a business of selling ornamental fish having his shop at Opposite Atragami Club, Pakhurtala more, Siliguri. During the course of running the said business one Dipankar Dutta @ Poltu (now deceased) was employed in the said shop. At this point of time Dipankar Dutta @ Poltu (now deceased) used to approach me and my husband for availing friendly accommodations. Seeing his mettle and dedication towards his work we used to help him upon humanitarian basis. Although unfortunately in the year 2021, the aforesaid Dipankar Dutta @ Poltu (now deceased) expired unnaturally leaving his wife Smt Pinki Dutta his two sons and his mother as his legal heirs. However, even after the death of the aforesaid Dipankar Dutta @ Poltu (now deceased) me and my husband used to help the aforesaid widow, Smt. Pinki Dutta in her every need. Even recently the aforesaid Smt Pinki Dutta had approached me for some financial help however, due to dwindling income of my husband I had to refuse her. It is pertinent to mention here that my husband had to close his business due to heavy losses and as such had to prefer working as a band leader of various singing bars for sustaining our family. Recently to my utter shock and surprise it has been discovered by me that my husband is having an illicit relationship with the aforesaid **Smt. Pinki Dutta**. After I confronted my husband he admitted that he has been having an illicit affair with the aforesaid Pinki Dutta. Even after witnessing such horrific admission I silently endured the same for the sake of the future of my son, hoping that one day my husband will come to his senses and resolve everything amicably. However, on 29.05.2025 at around 3.55 p.m when I was returning from my sons school i.e., Jermels Academy, Majhabari, I was brutally

confronted by the said Smt Pinki Dutta who suddenly came in front of me near **Badurbagan, Ashighar** without any rhyme or reason started hurling vulgar languages and assaults at me with fists and blows and also stated that she is in a relationship with my husband and that I should divorce my husband or else she will expose the intimate photos and videos of her with my husband in public/social media. She also stated that they are planning to marry each other and if I do not remove myself from the life of my husband she will kill me and make my son an orphan to fend for him on the streets and enjoy the property of my husband alone. She also bluntly refused to return the said money. Till date me and my husband have lent a sum of Rs.2,00,000/- (Rupees Two lakhs) only. Upon enduring the horrific incident I was deeply horrified and devastated to be publicly assaulted and abused at the hands of Smt Pinki Dutta. I am currently under utmost mental trauma and depression and also have an aspersion that if I fail to agree to the illicit demands of the said Smt Pinki Dutta she might endanger not only my life but the life of my minor son.

It is noteworthy to mention here that I have also observed that while being involved in the singing bar profession my husband has/had numerous illicit relationships with many ladies. Be it mentioned here that on various occasion the said since the aforesaid incident which took place on 29.05.2025 the aforesaid Smt Pinki Dutta has called me over telephone and threatened me that if I and my son do not leave the matrimonial house I and my son will have to face with dire consequences as such I was under utter mental shock and trauma and as such I could not file this written complaint on earlier occasion.

I therefore request you to take note of the aforesaid matter and book the culprit i.e., Smt Pinki Dutta, wife of Late Dipankar Dutta @ Poltu, in accordance to appropriate provisions of the Criminal Law.
