With due respect, I the undersigned Sri Chandan Pandey, Son of Sri Ganesh Pandey, BRI Colony, Siliguri Junction, Pradhan Nagar, Siliguri being the care taker of the plots of land properties of Sri Ashok Gupta of DA3MALLS LLP, Pradhan Nagar, Siliguri like to state that today on 15.06.2025, some persons appearing to be antisocial elements more than 100 in numbers led by one Sri Jai Prakash Agarwal, Sri Ankit Gupta and Sri Kailash Agarwal of Speed Fast Construction Private Limited forcefully entered in our plots of land/properties situated at Jugibhita, Sri Ram Colony, within Matigara Police Station Area, with lathi, bhala, iron rods etc. and snatched our mobile phones and threatened me and also the security guards of one Lokenath Securities namely Sri Arbinda Debnath, Resident of Naxalbari, Sri Kristo Kirtania, Resident of Naxalbari and Sri Manjit Barai, Resident of Naxalbari to leave the said plots of land/properties immediately or else they would finish my/our lives. It is stated that due to afraid of some danger of our life threat from their hands, we left the plots of land/properties and saw that they have broken the tins boundaries of the said plots of land and also stolen/carried the said broken tins long and stolen around 550 pieces of tins with one generator, 6 pieces hellogine lights and hardware goods and wooden furniture such as two beds, 8 pieces chairs and one wooden almirah lying therein with them in a Truck/TATA AC Vehicle Pick UP VEN WB72B6659.

It is to be mentioned here that the possession of the said plots of land was delivered by the Officers of the Indian Bank, Hill Cart Road, Siliguri to Sri Ashok Gupta of DA3MALLS LLP in presence of police team as per order of the Learned Court on 09.06.2025 and at the said time our firm took the possession of the said plots of land and bounded the said plots of land with the said

550 numbers of tins tins and also started to use the structure for residence of the security guards. At the said time, our firm asked me/other deputed three security guards as named herein above of Lokenath Securities to look after and protect the possession of the said plots of land/properties and belongings by guarding round the clock from the hands of the culprits. It is stated that I along with other three security guards would have been killed today if we do not left the said plots of land. I may identify the said Jai Prakash Agarwal, Ankit Gupta, Kailash Agarwal and some other anti social elements, if they are produced before me.

In view of the above, I therefore request your good office to book the culprits under the appropriate law and investigate into the matter and to recover the said tins and other belongings and also to punish the culprits.
