investigation. Damaged my house and when I tried to stop
them from going so then they started to assault
me by fists and bows punched my stomach
so that my child in the womb dies and even
tore my wearing apparels and suddenly one
of them hit me from back throttled me with
on intention to murder me and due to their
such throttling I was unable to breathe. If the
nearby people had not come then they would
have definitely killed me by throttling and
at the time of fleeing away they
even took my neck chain made of silver.

and doctor advised me to take rest and not
any movements for the safety of my unborn
child as such I did not lodge FIR
in due time for which I pray for condoning
my delay.

Station on 21.03.2025.

I therefore request you kindly take necessary
legal action against the culprits in the
aforesaid matters.
