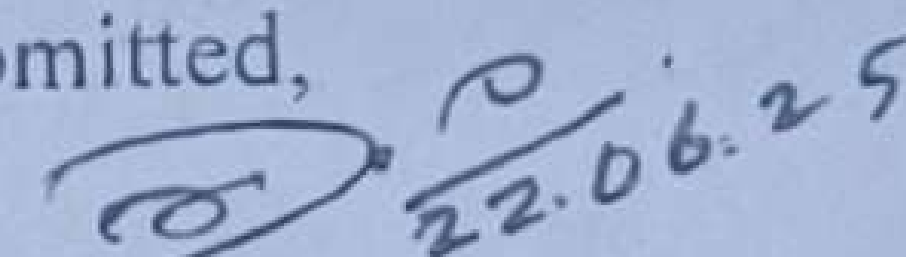
Subject: F.I.R

Sir

With due respect and humble submission I S.I Prasan Tamang of Matigara P.S. Siliguri Police Commissionerate, do hereby lodge this written complaint to the effect that on 22.06.2025 I was deputed to perform special Mobile Van duty along with force since 11.55 hrs, vide C.C. No. 1915/25, Dated 22/06/2025 and GDE No. 1256, Dated 22/06/2025 in the said mobile van duty I received source information that one Tractor is coming from Fulbari Patan towards Vastu Vihar side under Matigara PS loaded with river bed material which were procured clandestinely. Accordingly I informed the matter to I/C Matigara P.S over phone, he immediately directed me to work out the information in hand. Accordingly, I along with force rushed to "Vastu Vihar side and intercepted one Tractor bearing No. WB73F-3364 with trolley fully loaded with river bed materials near four Vedas under Matigara PS Dist Darjeeling. Seeing the police party the driver/owner of said Tractor fled away. It may be presumed that the Driver/Owner of said tractor procured the loaded riverbed materials, illegally and dishonestly, stealing by unfair means from somewhere, for his wrongful gain and to deliver the same to their designated customer. I searched for the Driver/Owner of the said Tractor in the surrounding areas but in vain. Nobody came forward to claim the said tractor with trolley loaded with Riverbed Materials. Finding no other alternatives, I seized the Tractor with Trolley bearing Regn No. WB 73 F 3364, loaded with river bed materials, preparing proper Seizure List and brought it to PS Compound. The whole process of search and seizure were made in between 13:35 hrs to 13:45 hrs on 22/06/2025 under proper videography.

Therefore, I pray before your kind honour that a specific case may kindly be registered against the driver/owner of Tractor with Trolley bearing No. WB 73 F 3364 loaded with river bed materials, and arrange for its investigation.

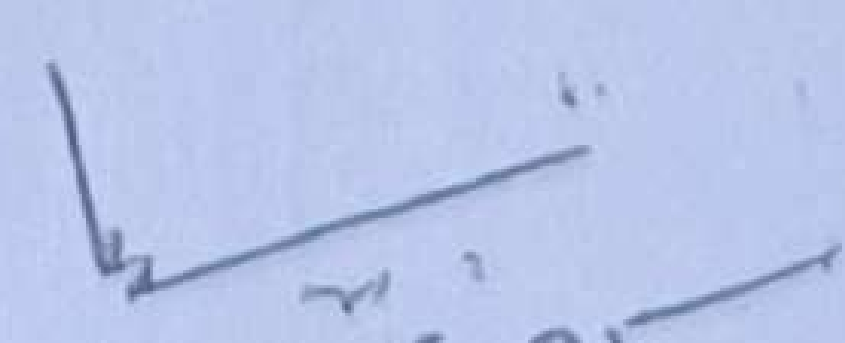
