Sir,

In producing herewith three arrested accused persons namely (1) Rupchand Sekh (34) S/O Lt Abdul Jabbar of Kaliyagachhi, PS- Lalgola, Dist- Murshidabad, (2) Gobinda Mazumder (44) S/O Lt Joy Kishore Majumder of Daldighi, PS- Gangarampur, Dist- Daskshin Dinajpur and (3) Ganesh Sha (37) S/O Mahadev Sha of Iscon Mandir Road, Shastri Nagar, Ward No. 41, PS- Bhaktinagar, Dist- Jalpaiguri A/P of Parbotighat, Baghajatin Colony, Ward No. 45, PS- Pradhannagar, Dist- Darjeeling along with the following seized articles under seizure as per seizure list:

- [1] One black coloured hand bag containing One transparent Plastic packet with 99.400 grms of suspected Brown Sugar
- [2] Indian Currency Note of Rs. 1,00,000/- , Denomination as i) Rs 500 X 198 and ii) Rs. 200 X 5
- [3] One Redmi 10 mobile hand set bearing IMEI (Slot 1) No. 860815067230409/00 of accused Ganesh Sha
- [4] One Realme C11 mobile phone bearing IMEI (slot 1) No. 865313059450651/01 of accused Rupchand Sekh
- [5] One Realme 9i 5G mobile phone bearing IMEI (slot 1) No. 864412067309171/14 of accused Gobinda Mazumder.

I, SI Ganesh Roy of DD, SPC do hereby lodged this written complaint against above mentioned three accused persons to the effect that today on 20.06.2025 at about 14.05 hrs I received a specific source input that today afternoon , one person namely Rupchand Sekh is coming to Siliguri Junction area from Lalgola Murshidabad with brown Sugar for delivering the same to the designated customers at back side of Siliguri Junction for his wrongful gain. The matter was diarized in DD, SPC GDE No. 127, Dtd- 20.06.2025 and subsequently, I informed the matter to the ACP, DD, SPC and being directed, at 14.15 hrs myself along with SI Biswajit Ghosh, SI Krishna Parja, ASI Sushanta Dey, ASI Sagar Das, Const-670 Ratan Roy and Const-686 Arup Saha all of DD, SPC left for Siliguri Junction area under pradhannagar PS with govt. vehicle along with investigation kit to verify the veracity of the information vide DD, SPC GDE no. 128 , Dt- 20.06.2025 and M.C.C No- 154/2025 Date- 20.06.2025.

While going towards Siliguri Junction, on the way, I requested two independent witnesses namely (1) Mahesh Sah (19) S/O Lt Chandrika Sah of Gate Bazar, BRI Colony, Ward No. 46, PS- Pradhannagar, Dist- Darjeeling and (2) Rahit Sah (19) S/O Ratan Sah of Gate Bazar, BRI Colony, Ward No. 46, PS- Pradhannagar, Dist- Darjeeling in written to remain present as witness during search and seizure if any. They gave their willingness and accompanied with us.

Thereafter at about 14.50 hrs we reached at backside of Siliguri Junction and as shown by the source we cordoned a specific place behind junction near railway track. At about 15.35 hrs on being pointed by source we found three persons interacting each other and we detained them. We disclosed our identity and on question the they disclosed their name and address as (1) Rupchand Sekh (34) S/O Lt Abdul Jabbar of Kaliyagachhi, PS- Lalgola, Dist- Murshidabad, (2) Gobinda Mazumder (44) S/O Lt Joy Kishore Majumder of Daldighi, PS- Gangarampur, Dist- Daskshin Dinajpur and (3) Ganesh Sha (37) S/O Mahadev Sha of Iscon Mandir Road, Shastri Nagar, Ward No. 41, PS-

tinagar, Dist- Jalpaiguri A/P of Parbotighat, Baghajatin Colony, Ward No. 45, PS- Pradhannagar, Dist- Darjeeling . We also disclosed them about the information in hand. On interrogation they confessed that Rupchand Sekh procured Brown Sugar illegally and came to Siliguri with Brown Sugar to sell the same to Gobinda Mazumder and Ganesh Sha for his wrongful gain . Gobinda Mazumder and Ganesh Sha confessed that they use to sale the same to their designated customers in small purias in high price for their wrongful gain. I gave them option in writing whether they wanted to be searched in presence of a Magistrate or in presence of a Gazetted Officer. They gave their consent for search in presence of a Gazetted Officer.

Accordingly, I informed the matter ACP DD, SPC and as per his direction, informed Sri Abhijit Dutta, Inspector of Police, DD, SPC regarding the interception of the accused persons suspected to be possessed Brown Sugar and requested him to come at backside Siliguri Junction near Railway track under Pradhannagar PS to remain present and to supervise the search and seizure .

Accordingly at 16.15 hrs Sri Abhijit Dutta, Inspector of Police, DD, SPC arrived at the spot and subsequently, under his supervision, in presence of witnesses the process of search of the detained persons were conducted following all formalities and recovered the total 99.400 grms suspected Brown Sugar from the possession of accused Rupchand Sekh and cash Rs. 1,00,000/- from accused Ganesh sha and Gobinda Mazumder. The above noted articles were seized from the exclusive and conscious possession of above noted accused persons. Subsequently, being demanded in presence of Sri Abhijit Dutta, Inspector of Police, DD, SPC the detained persons failed to produce any valid document in support of possessing of the suspected brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found total 99.400 grms suspected Brown Sugar from exclusive possession of accused persons and marked as "Exhibit- A" which I sealed and labelled in presence of the Gazetted officer. I also seized Cash Rs. 1,00,000/- and three mobile phones as noted at the spot under proper seizure list under videography and duly signed by above noted witnesses and the Gazetted officer and acknowledged by the accused persons. The whole process of seizure was made in between 16.20 hrs and 17.05 hrs on 20.06.2025. Then, I arrested the above noted accused persons after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons are involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely (1) Rupchand Sekh (34) S/O Lt Abdul Jabbar of Kaliyagachhi, PS- Lalgola, Dist- Murshidabad, (2) Gobinda Mazumder (44) S/O Lt Joy Kishore Majumder of Dhaldighi, PS- Gangarampur, Dist- Daskshin Dinajpur and (3) Ganesh Sha (37) S/O Mahadev Sha of Iscon Mandir Road, Shastri Nagar, Ward No. 41, PS- Bhaktinagar, Dist- Jalpaiguri A/P of Parbotighat, Baghajatin Colony, Ward No. 45, PS- Pradhannagar, Dist- Darjeeling and others and arrange for its investigation.
