Respected Sir,

I, Adarsh Kumar Prasad, son of Shiv Kumar Prasad, resident of Nivedita Road, Gurung Basti, Ward No. 3, P.O & P.S.- Pradhan Nagar, District- Darjeeling, Pin Code - 734003 in the state of West Bengal beg to state as follows:

That on 18/06/25 at around 3:30 am when my younger brother namely Nikhil Prasad @ Ritikesh Prasad and his friend namely Munna Roy was returning home from City Centre Mall, Matigara, Siliguri, due to some urgent work purpose, at that time one antisocial namely Roshan Tamang S/o - Mani Kumar Tamang of Salugara, Post Office Road, P.O. Salugara, P.S. Bhaktinagar, District - Jalpaiguri, along with his friends stopped the way of my brother & his above named friend at Bhanu Bhakta Sarani, Gurung Basti, Ward No 03 (S.M.C.), P.S. - Pradhan Nagar and started using abusive languages with my brother & his above named friend as Roshan Tamang was highly intoxicated and when my brother & his above named friend came down from their car to tackle the situation by a healthy conversation, they noticed that Roshan Tamang was not only highly intoxicated but he was unable to stand by on his own feet. When my brother & his above named friend started to make him cool down he suddenly started hitting my brother & his above named friend with fists and blows brutally and also slapped them continuously and show his pistol towards them and tried to hit my brother on his head with the said pistol with the intention to kill him and started giving them death threats but somehow he managed to dodge from his attack and save his life. After that my brother & his above named friend was very much frightened due to this incident and when they further tried to convince Roshan Tamang and to solve the situation, then Roshan Tamang again abused them with filthy languages and told them that he will kill them whereever he sees them. After realizing that Roshan Tamang was not in condition to understand anything so it was baseless to talk to Roshan Tamang and for avoiding further quarrel, when they came back to their car for returning home, then all of a sudden Roshan Tamang out of anger and because he

was highly intoxicated, he drove rashly his car towards my brother's friend's car and smashed their car being no. WB74AQ1212 (Maruti Suzuki Baleno). Due to this, the car was totally damaged and my brother and his friend was somehow managed to escape from death because Roshan Tamang's only intention was to kill my brother and his friend. After the above-mentioned incident, my brother and his friend was mentally traumatized and the situation horrifies them so much that after that incident, they both did not came home till now due to the death threat of the above-mentioned Roshan Tamang because he told them whenever they return to their house, he will kill both of them.

Therefore, it is my earnest request to you to take necessary legal action against the above named accused person who is continuously giving death threats to my brother and his friend and tried to kill them. Sir, we are passing our days in extreme fear and anxiety.
