Respected Sir,

This is to inform you that I Sri, Raju Kumar Prasad Son of Late. Prabhu Nath Prasad resident of Santoshi Nagar, Netaji Road, Ward No.5 of S.M.C, P.O and P.S Siliguri, Dist:- Darjeeling is married to one Smt. Chulbul Prasad Daughter of Sri.Sunil Singh resident of Pakistan Busty, Near Chamta Bridge, Opposite Bartaman Paper mill, Matigara, P.O and P.S Matigara, Dist:- Darjeeling. That from the very inception of our marriage the said Chulbul Prasad has been conducting immense cruelty upon me and my family members, and she never performed any of her matrimonial duties and obligations. That my wife has always used me for her unwarranted demands and materialistic greed, and whenever I failed to meet her demands due to my financial incapacity I was subjected to immense torture by my wife namely Chulbul Prasad. That my wife on frequent occasion used to move into her parental home and after several persuasion from my end I used to again bring her back to her matrimonial home. It is pertinent to mention here that my in law members also used to extremely interfere in my matrimonial life and used to give ill advise to my wife with regard to extorting money and valuable articles from me. That on 10.06.2025 my wife at her whims and fancy without any reason whatsoever moved out of her matrimonial home and shifted to her parental home at Matigara. That I tried to call her several times to come back to her matrimonial home but she adamantly refused the same. That subsequently on 17.06.2025 at about 7:00 P.M. I physically visited my in-law's place at Matigara to meet my wife and bring her back to her matrimonial home at Santoshi Nagar, Siliguri. That upon reaching my in law's place at Matigara my wife served me water, and after consuming the said water I started feeling dizzy and weak. That thereafter my wife Chulbul Prasad, her father Sri.Sunil Singh, her mother namely Smt. Shanti Devi Singh, her brothers Sri. Gunjan Singh and Sri. Niku Singh, tied me with rope and started to physically assault me with kicks and blows and demanded five lacs cash from me. That when I refused to pay the said amount my wife's brother Sri. Gunjan Singh shouted "Aaj tujhe Maar hi Dalunga" and thereafter the said Sri. Gunjan Singh and Niku Singh cut my body with sharp weapon with an intention to kill me. That thereafter as it was getting late one Sri. Munna Kumar visited my in law's house and seeing my condition he rang my mother namely Smt Mina Devi and my Sister-in-law namely Smt. Rita Devi. That thereafter my mother and sister-in-law came to my wife's parental home and was shocked to see my condition and they requested my wife and his family members to release me, but on seeing

my mother and sister-in-law the said Sunil Singh, Gunjan Singh and Niku Singh physically abused my mother and sister-in-law and tore their apparel thereby outraging their modesty. That subsequently after hearing our hue and cry for help with local interference I alongwith my mother and sister-in-law was rescued from the hand of my wife and her family members namely Sunil Singh, Shanti Devi Singh, Gunjan Singh and Niku Singh and was taken to Matigara Hospital for treatment. It is pertinent to mention here that as I was under extreme stress and trauma and also was under the fear of lodging any complainant against my wife and his family members as they had threatened to kill me if I lodged any complaint against them before any authority, hence there is a delay in lodging this instant complaint.

Hence I request before your goodself to kindly look into the abovementioned matter and take necessary legal action against my wife namely Smt. Chulbul Prasad, her father Sri. Sunil Singh, her mother Smt. Shanti Devi Singh, her brothers namely Sri. Gunjan Singh and Sri. Niku Singh as per legal procedure for the end of Justice.
